Lee County offers update on FEMA National Flood Insurance Program issue

Fort Myers, FL, April 15, 2024 – Lee County will provide an update Tuesday related to FEMA's announcement that it would alter discounts on National Flood Insurance Program (NFIP) premiums by retrograding the county's and four municipalities' Community Rating System (CRS) classifications.
