**TITLE:**

Approve Amendments to the Solid Waste and Recycling Collection Franchise Agreements for a three-year-term extension

**ACTION REQUESTED:**

- A) Approve Amendments to the existing Solid Waste and Recycling Collection Franchise Agreements for a three-year-term extension with Advanced Disposal Services (Solid Waste Franchise Areas 1 and 2) and Waste Pro of Florida (Franchise Areas 3 and 5) beginning October 1, 2017 and ending September 30, 2020.
- B) Authorize the Chair to execute the contract documents of behalf of the Board of County Commissioners.

**FUNDING:**

No funds required for this request.

**WHAT ACTION ACCOMPLISHES:**

Amends and extends the current service agreements to September 30, 2020 for residential, multi-family, and commercial solid waste and recycling collection services in four service areas: Franchise Areas 1 (Town of Fort Myers Beach, City of Bonita Springs), Franchise Area 2 (Iona-McGregor), Franchise Area 3 (South Fort Myers), and Franchise Area 5 (North Fort Myers and Pine Island) and holds current vendor residential service fees and rates for the duration of the extension.

**Background:**

With the award of RFP-10-01, Residential, Multi-Family, and Commercial Solid Waste and Recycling Collection service agreements went into effect on October 1, 2010. These agreements were for an initial five year term.

In accordance with Board direction received on September 22, 2014 at the Board meeting related to contract extensions and residential service upgrades to the recycling system (purchase and distribution of wheeled recycling carts) service agreements for Franchise Areas 1, 2, 3 and 5 were extended for two additional years (to September 30, 2017).

A clause in this amendment provides the County the discretion for an additional three-year contract renewal.

During the course of the contract Waste Pro of Florida (Franchise Areas 3 and 5) and Advanced Disposal Services (Franchise Areas 1 and 2) have demonstrated satisfactory service performance and built good

working relations with the Lee County Solid Waste Division as well as in the communities these companies service. Both contractors are experienced, reliable and represent a strong, diverse workforce in Lee County. Current Fees and Rates for residential services will remain unchanged for the duration of the three year extension. Commercial Recycling Collection rates are modified not to exceed the MSW Collection rates. This change in Commercial Recycling Collection rates will satisfy conditions of a lawsuit brought against the County related to recycling services and rate setting.

Consistent solid waste services are crucial in maintaining the health and welfare of a community. Exercising the available renewal of these agreements ensures ongoing services for these franchise areas through 2020.
