#### LEE COUNTY ORDINANCE NO. 24-XX

ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, RELATING TO ANCHORING LIMITATION AREAS PROVIDING FOR DEFINITIONS; INTERLOCAL AGREEMENTS; DESIGNATED ANCHORING LIMITATION AREA(S); FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION ("FWC") NOTICE; ENFORCEMENT; CONFLICTS OF LAW; SEVERABILITY; CODIFICATION AND SCRIVENER'S ERRORS: PROVIDING **MODIFICATIONS** FOR THAT MAY ARISE CONSIDERATION AT PUBLIC HEARING; AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 327.4108, Florida Statutes, counties have been granted the exclusive right and authority to enact ordinances establishing anchoring limitation areas adjacent to urban areas that have residential docking facilities and significant recreational boating traffic upon at least thirty (30) days' prior notice to the Florida Fish and Wildlife Conservation Commission ("FWC") before introducing this type of ordinance; and

WHEREAS, Section 327.4108, Florida Statutes, also requires that anchoring limitation areas be marked with signage and buoys permitted by the FWC; and

WHEREAS, Section 327.4108, Florida Statutes, also requires that anchoring limitation areas be less than 100 acres in size; the calculated size of an anchoring limitation area shall not include any portion of the marked channel of the Florida Intracoastal Waterway or any mooring field or marina; and the aggregate total of anchoring limitation areas in Lee County do not exceed ten percent (10%) of the County's delineated navigable-in-fact waterways; and

WHEREAS, the City of Cape Coral has requested that the County establish an anchoring limitation area in the Bimini Basin within the City of Cape Coral.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA THAT:

#### SECTION ONE: DEFINITIONS

For the purposes of this article, the following terms apply:

Anchoring Limitation Area means an area in which a person may not anchor a vessel for more than forty-five (45) consecutive days in any six (6) month period, subject, however, to the exemptions in Sections 327.4108(4)-(5), Florida Statutes.

*Person* means an individual, partnership, firm, corporation, association, or other entity.

Vessel is synonymous with boat as referenced in Article VII, Section 1(b), of the Florida Constitution and includes every description of watercraft, barge, and airboat, other than a seaplane on the water, used or capable of being used as a means of transportation on water.

#### SECTION TWO: INTERLOCAL AGREEMENTS

Municipalities may be required to enter into an Interlocal Agreement with Lee County in order to set forth respective responsibilities and obligations regarding designated Anchoring Limitation Areas.

#### SECTION THREE: DESIGNATED ANCHORING LIMITATION AREA(S)

The following area(s) within Lee County, Florida, are hereby designated as an Anchoring Limitation Area:

i. Exhibit A: Bimini Basin Anchoring Limitation Area ("Bimini Basin ALA"). The Bimini Basin ALA is subject to the terms and conditions of the Interlocal Agreement entered into between the County and the City of Cape Coral on June 18<sup>th</sup>, 2024, as may be amended. In the event a mooring field or marina is created within the Bimini Basin, the Bimini Basin ALA will be deemed null and void and unenforceable.

#### SECTION FOUR: FWC NOTICE

At least thirty (30) days' prior notice was provided to FWC before the introduction of this ordinance.

#### SECTION FIVE: ENFORCEMENT

Enforcement of this article is as provided for in Sections 327.4108(6)-(7) and 327.73(1)(z), Florida Statutes. Any law enforcement officer or agency with jurisdiction can enforce the provisions of this ordinance. The City of Cape Coral will be primarily responsible for the enforcement of the Bimini Basin ALA.

#### SECTION SIX: CONFLICTS OF LAW

Whenever the requirements or provisions of this Ordinance are in conflict with the requirements or provisions of other lawfully adopted ordinances or statutes, the most restrictive requirements will apply.

#### SECTION SEVEN: SEVERABILITY

If any provision of this ordinance is deemed invalid or unconstitutional by a court of competent jurisdiction, it is the Board's intention that such portion will become a separate provision and will not affect the remaining provisions of the ordinance. The Board further declares that this ordinance would have been adopted if such unconstitutional provision was not included.

#### SECTION EIGHT: CODIFICATION AND SCRIVENER'S ERRORS

The Board intends that this ordinance will be made part of the Lee County Code; and that sections of this ordinance can be renumbered or relettered and that the word "ordinance" can be changed to "section", "article" or some other appropriate word or phrase to accomplish codification, and regardless of whether this ordinance is ever codified, the ordinance can be renumbered or relettered and typographical errors that do not affect the intent can be corrected with the authorization of the County Manager or his designee, without the need for a public hearing.

### SECTION NINE: MODIFICATIONS THAT MAY ARISE FROM CONSIDERATION AT PUBLIC HEARING

It is the intent of the Board of County Commissioners that the provisions of this Ordinance may be modified as a result of consideration that may arise during Public Hearing(s). Such modifications shall be incorporated into the final version.


