Commissioner Kevin Ruane was first elected to the Lee Board of County Commissioners in November 2020 after serving as the Mayor of Sanibel for more than a decade. He has served as Chair and Vice Chair. In 2024, he ran unopposed for his second term. After Hurricane Ian, Commissioner Ruane was appointed by the Board as the Chair of the Long-term Recovery Task Force.

Kevin was appointed to the Sanibel City Council to serve an interim position in February 2007. In May 2007, he was elected and re-elected in March 2009. He was appointed Mayor in March 2010. He was subsequently re-elected in 2013 and 2017.

Kevin served as a voting delegate for the Florida League of Cities. In 2020, he was awarded the E. Harris Drew Municipal Official Lifetime Award.

In 2014, Gov. Rick Scott appointed Kevin to the South Florida Ecosystem Restoration Task Force and re-appointed in 2019 by Gov. Ron DeSantis.

Kevin attended both undergraduate and graduate schools at Pace University. He took over his family's CPA firm. His corporate career included various senior executive positions with a subsidiary of a Fortune 100 company.

Kevin owns Castleton Capital specializing in small business lending, business acquisition, equipment financing and franchise lending.
