



## **NOTICE OF PUBLIC COMMENT PERIOD For Amendments to the Lee County Annual Action Plans**

In accordance with U.S. Department of Housing and Urban Development (HUD) regulations governing Community Development Block Grant (CDBG), Community Development Block Grant Cares Act (CDBG-CV), HOME Investment Partnership Program (HOME), and Emergency Solutions Grant (ESG) programs including Emergency Solutions Grant Rapid Unsheltered Survivor Housing (ESG-RUSH), Lee County hereby notifies the public that beginning on January 22, 2025, and ending on February 3, 2025 public comment will be accepted on the proposed changes to the HUD 2020, HUD 2021, HUD 2023, and HUD 2024 Annual Action Plans. - Transfer \$564.09 in CDBG funds from CDBG Non-Profit Capital Improvement to CDBG Housing Rehabilitation and Reconstruction

### **HUD Year 2023**

- Transfer \$20,050.00 in CDBG funds from CDBG Homeownership Assistance to CDBG Housing Rehabilitation and Reconstruction

### **HUD Year 2024**

- Transfer \$26,000.00 in CDBG funds from Public Services to Non-Profit Capital Improvement/Public Facility/Infrastructure
- Transfer \$5,000.00 in ESG-RUSH funds from Rapid Rehousing to Program Administration
