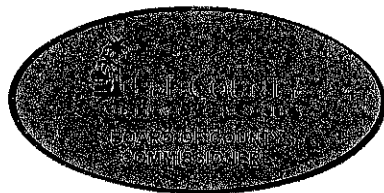
**Whereas:** Once again, it is our great pleasure to welcome the Minnesota Twins and their families to Lee County for the beginning of spring training; and
