7. BACKGROUND:

As a result of the annual inspection performed by the Florida Department of Transportation to the Matlacha Bridge, it was determined that immediate repairs were needed to the corroded stringers and webs or failure was evident. On February 5, 2002 the Board approved Bid Waiver BW-02-06 to Coastal Marine Construction Inc. in the amount of \$72,274.00, for these Immediate Repairs as a result of that inspection.

While Coastal Marine Construction was performing this work it was discovered that additional repairs are needed to the bridge. Therefore, the Department of Transportation is requesting Board approval to increase this Bid Waiver to an estimated not-to-exceed amount of \$100,000.00, for these additional repairs.
