BEACH AND SHORLINE PROJECT REQUEST FORM FY 02-03 U.S. Fish and Wildlife Service J.N. "Ding" Darling National Wildlife Refuge TARPON BAY DOCK

I Project Summary – The wooden Tarpon Bay Dock will be rebuilt with recycled plastic lumber decking and marine-grade pressure-treated wood pilings, stringers and joists.

II Project Abstract

- A. Project Description: The 90-foot long wooden dock needs to be replaced. The dock partially collapsed on October 10, 2001. This dock is located at Tarpon Bay Recreation Area and is utilized by 170,000 visitors each year. The dock is used to access private boats, rental canoes and kayaks, and tour boats. The project consists of
 - i. removing the existing wooden dock.
 - ii. rebuilding the Tarpon Bay Dock with marine-grade pressure treated wood (pilings, stringers and joists) and recycled plastic lumber (decking).
 - iii. constructing the dock to meet ADA accessibility standards.

Recycled plastic lumber (reinforced with fiberglass) will be used for the decking. This high quality material has been used on the Refuge's Shell Mound Trail boardwalk, Administrative Building and Visitor Center entrance ramp, and the government dock and by the City of Sanibel for beach boardwalks. The material should last 30+ years, which will reduce the need and costs to replace the dock every 15 years.

- B. Overall Context: Interpretive signage will be added to the adjacent viewing deck within the next two years.
- A. Impact to Tourism: The J.N. "Ding" Darling National Wildlife Refuge is located on Sanibel Island and is one of the most popular tourist destinations in Lee County. The Tarpon Bay Recreation Area is located on the refuge and provides a variety of recreational opportunities to local residents and tourists: boat launching, canoe and kayak rental, canoe trails, fishing, and nature tours (estuary and bird rookery tours).

Over 800,000 people visit the refuge each year. Approximately 170,000 visitors use the Tarpon Bay Recreation Area annually. This dock was closed to public use in October 2001 after it collapsed. Unfortunately, this severely impacted visitors and their ability to safely access private boats, canoes and kayaks.

B. Estimate Project Time: Permitting: 30 days

Construction: 45 days



The U.S. Fish and Wildlife Service (Service) appreciates the support the Tourist Development Council (TDC) has provided the J.N. "Ding" Darling National Wildlife Refuge (Refuge) during the past years. You have assisted us with funding several important projects: Shell Mound Trail Boardwalk, Wildlife Drive Fishing Pier (planned completion Summer 2002), and the Indigo Trail Boardwalk (planned completion Fall 2002). Additionally, you have assisted with our exotic plant program through the City of Sanibel. Your partnership with the Refuge has greatly improved our ability to provide quality services to our visitors.

In October 2001, the Tarpon Bay Dock collapsed, preventing Refuge visitors from easily accessing private and rental canoes/kayaks and boats. Unfortunately, due to the funding cycles of the Federal Government, the U.S. Fish and Wildlife Service was unable to fund this project during FY 2002 (October 1, 2002 through September 30, 2003). Fortunately, on March 1, the Tourist Development Council agreed to fund this project.

During the next funding cycle for FY 2003, we will continue to request funding for the Tarpon Bay Dock replacement (approximately \$45,000). If this project is funded, we will request that the Service consider using this funding to off-set TDC costs on the Indigo Trail Boardwalk.
