**ACTION REQUESTED:** Award B-02-15 TRANSPORT OF MUNICIPAL SOLID WASTE, for the Division of Solid Waste, to the lowest responsive/responsible bidder meeting all bidding requirements, Carlos Trucking Inc., for the amounts as follows: \$147.20/per truck load (Clewiston to WTE); \$102.00/per truck load (Labelle to WTE); \$147.20/per truck load (Clewiston to Lee/Hendry Landfill); and \$102.00/per truck load (Labelle to Lee/Hendry Landfill), for a contract period of two (2) years with two (2), one (1) year renewal options.

**WHY ACTION IS NECESSARY:** Pursuant to Administrative Code AC-4-4 Lee County Contract Manual, approved by the Board on September 25, 2001, services in excess of \$50,000.00 shall be executed through the formal process.

**WHAT ACTION ACCOMPLISHES:** Provides Solid Waste with a hauler to supply all required labor, supplies, fuel, equipment, and Vehicles to transport and unload municipal solid waste from the Clewiston and Labelle Transfer Stations to the Waste to Energy Facility or the Lee/Hendry Landfill.

**7. BACKGROUND:**

The Division of Solid Waste submitted a request to Contracts Management to obtain bids for the Transport of Municipal Solid Waste. The expected cost of the services required the use of the formal process.

On the bidding deadline of April 10, 2002, Contracts received four (4) bids. The bids have been reviewed by the Division of Solid Waste and it is being recommended that award be made to the lowest responsive/responsible bidder meeting all bidding requirements, Carlos Trucking Inc., for the amounts as follows: \$147.20/per truck load (Clewiston to WTE); \$102.00/per truck load (Labelle to WTE); \$147.20/per truck load (Clewiston to Lee/Hendry Landfill); and \$102.00/per truck load (Labelle to Lee/Hendry Landfill), for a contract period of two (2) years with two (2), one (1) renewal options. The estimated expenditure is expected to be \$400,000.00/per year at About 1,562 truck loads per location.

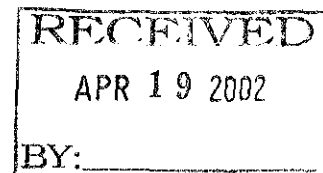
