# RESOLUTION #

## RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA TO SUPPORT THE REAUTHORIZATION OF THE LIBRARY SERVICES AND TECHNOLOGY ACT

**WHEREAS:** The Library Services and Technology Act (LSTA) is the nation's library aid program, and was created as part of the Museum and Library Services of 1996; and

**WHEREAS:** H.R. 3784, the Museum and Library Services Act of 2002 has been filed in the U.S. House of Representatives to reauthorize the law and must be passed by October 1, 2002 to allow funding to continue; and

**WHEREAS:** The passage of H.R. 3784 would accomplish several things including a funding increase for the State of Florida which would allow for the creation of the "Florida Virtual Library", provides badly needed improvements in school media centers, provides for support of discounted telecommunications services to public schools and libraries, supports a balanced approach to copyright and "fair use" principals and supports e-government" to ensure public access to electronic government information.

**WHEREAS:** The Lee County Library Division and the Lee County Library Advisory Board advocates the passage of H.R. 3784.

**NOW THEREFORE, BE IT RESOLVED THAT THE LEE COUNTY BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA HEREBY:**

1. Strongly supports H.R. 3784, the reauthorization of the Library Services and Technology Act and any similar legislation as filed by the U.S. Senate.
2. Hereby directs County Administration to forward a copy of this Resolution to the Honorable Senator Robert Graham, the Honorable Senator William Nelson and the Honorable Representative Porter Goss.
