7. BACKGROUND:

Riverdale Shores Improvement Unit was created by Ordinance 80-23 for the purpose of maintaining landscaping to the entrance on Buckingham Road and doing some maintaining of drainage in the development. The area developed differently than anticipated. The final phase is being developed separately as a gated community, which is different from the original plans. The primary entrance and exit for the new community will be on Palm Beach Blvd. Therefore, this action is a request to amend the legal description to reflect what has actually happened by severing the new community from the Riverdale Shores Improvement Unit now that the area is in the final phase of development. Property Owners of the Riverdale Shores Improvement Unit will continue to contribute to their own MSTU and will still receive the benefits of the landscaping of their entrance and any remaining drainage maintenance. The new development will be responsible for the drainage outfall for the entire community. The landscaping for the new development will be its own responsibility.

LEE COUNTY ORDINANCE NO. _____

AN ORDINANCE AMENDING LEE COUNTY ORDINANCE NO. 80-23 RELATING TO THE RIVERDALE SHORES IMPROVEMENT UNIT; AMENDING SECTION TWO PROVIDING FOR THE BOUNDARIES TO BE INCLUDED; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners is the governing body in and for Lee County, a charter county and political subdivision of the State of Florida, and holds all powers granted to counties pursuant to the Florida Constitution and state statutes; and

WHEREAS, the Lee County Board of County Commissioners had previously adopted Ordinance No. 80-23 relating to the creation of the Riverdale Shores Improvement Unit; and

WHEREAS, the Board of County Commissioners of Lee County now desires to amend Lee County Ordinance No. 80-23 in order to provide for an amended legal description.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR LEE COUNTY, FLORIDA, that:

SECTION ONE:

This Ordinance amends Lee County Ordinance 80-23 as set forth herein. The amendments and revisions set forth in the following sections are hereby adopted.

SECTION TWO: CREATION OF THE UNIT AND BOUNDARIES

Section Two of Lee County Ordinance 80-23 is hereby amended to change the legal description to:

SEE ATTACHED LEGAL DESCRIPTION WHICH IS
LABELED EXHIBIT A HEREBY INCORPORATED
BY REFERENCE.

SECTION THREE: SEVERABILITY

The provisions of this Ordinance are severable, and it is the intention to confer to the whole or any part of this Ordinance the powers herein provided for. If any of the provisions of this Ordinance shall be held unconstitutional by any court of competent jurisdiction, the decision of such court shall not affect or impair any of the other remaining provisions of this Ordinance. It is hereby declared to be the legislative intent that this Ordinance would have been adopted had such an unconstitutional provision not been included herein.

SECTION FOUR: EFFECTIVE DATE

This Ordinance shall take effect immediately upon receipt of notice from the Florida Department of State of its filing with that office.

AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE CREATING THE RIVERDALE SHORES IMPROVEMENT UNIT, A MUNICIPAL SERVICE TAXING OR BENEFIT UNIT; PROVIDING FOR DEFINITIONS; ESTABLISHING THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA AS THE GOVERNING BODY OF THE UNIT; DESCRIBING THE BOUNDARIES OF THE UNIT; PROVIDING THE GOVERNING BODY WITH THE GENERAL POWERS INCLUDING THE POWER TO LEVY AND COLLECT SPECIAL CHARGES, TAXES OR SPECIAL ASSESSMENTS; PROVIDING THE GOVERNING BODY WITH THE POWER TO CONSTRUCT, IMPROVE AND MAINTAIN RECREATION SERVICE AND FACILITIES AND DRAINAGE FACILITIES; PROVIDING THE GOVERNING BODY WITH THE POWER TO ACCEPT GRANTS AND/OR LOANS FROM ANY STATE, FEDERAL OR NONPROFIT ORGANIZATION; PROVIDING FOR CONDITIONS PRECEDENT TO THE ACCEPTANCE OF RECREATIONAL AND DRAINAGE FACILITIES; PROVIDING FOR SEVERABILITY; PROVIDING FOR ALTERNATE OR SUPPLEMENTAL AUTHORITY; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, a petition to establish a municipal service taxing or benefit unit was presented to the Board of County Commissioners with signatures of at least sixty-five percent (65%) of the record title holders residing with the proposed unit; and,

WHEREAS, a Notice of Intent to Enact an Ordinance has been kept by the Clerk of the Board of County Commissioners in a separate book which was open for public inspection during regular business hours and has been published in a newspaper of general circulation within Lee County at least fifteen (15) days prior to this hearing, excluding Sundays and holidays; and,

WHEREAS, a notice of this public hearing was mailed to all record title holders within the proposed unit; and,

WHEREAS, the proposed Recreational Service and Drainage Facilities Program has been described to this Board to include the estimated cost of constructing, improving and maintaining the facilities; and,

WHEREAS, all persons having an interest in the proposed improvements and the public at large were given an opportunity to be heard; and,

WHEREAS, the Board of County Commissioners of Lee County, Florida has found and determined that the proposed Riverdale Shores Improvement Unit is necessary and desirable for the protection of the health, safety and welfare of the property owners and residents residing within the unit.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, that:

SECTION 1.

DEFINITIONS

Unless another meaning is plainly indicated, the following words and phrases shall have the following meanings:

"Board" shall mean the Board of County Commissioners acting as the governing body of the county or of a municipal service taxing or benefit unit.

"Property owner" shall mean any owner of an interest in realty within the boundaries of the unit.

"Record Equitable Title Holder" shall mean any equitable owner of a present possessory interest in realty within the boundaries of the unit who has recorded his instruments of title.

"Record Legal Title Holder" shall mean any legal owner of a present possessory interest in realty within the boundaries of the unit who has recorded his instrument of title.

"Record Title Holder" shall mean any legal or equitable owners of a present possessory interest in realty within the boundaries of the unit, who have recorded their instrument of title.

"Unit" shall mean the Riverdale Shores Improvement Unit.

SECTION 2.

CREATION OF THE UNIT, PURPOSE AND BOUNDARIES

Pursuant to the powers granted to the Board by the Constitution of the State of Florida and the Florida Statutes,

... particular, Section 125.01, Fla. Stat., the Board hereby --
creates a municipal service taxing or benefit unit to be
known as the RIVERDALE SHORES IMPROVEMENT UNIT. With the
exception of the Notice required by Section 125.66, Fla. Stat.,
and any other procedure required by state statute prior to the
enactment of an ordinance, any and all procedures, administrative
or otherwise, which were required to be followed prior to the
enactment of this ordinance shall be considered directory in
nature and non-compliance with these procedures shall have no
effect upon the validity of this ordinance, constitutionally or
otherwise.

The purpose of the RIVERDALE SHORES IMPROVEMENT UNIT is
to provide the following municipal services within the
boundaries of the unit:

1. Maintenance, improvement or construction of
approved recreational facilities and providing
recreational services for such approved
recreational facilities.
2. Maintenance, improvement or construction of
approved drainage facilities.

The boundaries of the Unit shall be as follows:

See legal description attached hereto and
made a part hereof and marked Exhibit "A".

SECTION 3.

THE GOVERNING BODY

The Board of County Commissioners of Lee County, Florida
shall be the governing body of the RIVERDALE SHORES IMPROVEMENT
UNIT. The Board may appoint an advisory committee composed
of five (5) persons who own property and/or reside within
the Unit. The term of office and method of appointment
of the advisory committee shall be established by the Board.

SECTION 4.

GENERAL POWERS

The governing body shall have all the powers necessary
or convenient to carry out the purpose of this ordinance and
such additional rights and powers as are provided by the

Constitution of the State of Florida and the laws of the State of Florida as granted to counties. The governing body shall also have the powers not otherwise prohibited by law and these powers shall include but not be limited to the following:

1. Sue or be sued, complain or defend in the name of the County, or the municipal service taxing or benefit Unit in any and all courts or administrative agencies;
2. Acquire by grant, purchase, gift, devise, exchange or in any other lawful manner any property, real or personal or any estate or interest therein upon such terms and conditions as the governing body may determine;
3. Enter into contracts with any public, quasi-public, private person or corporation for the furnishing of the improvements within the boundaries of the Unit;
4. Levy and collect taxes or special charges or special assessments within the Unit;
5. Borrow and expend money and issue bonds, revenue certificates, and such other obligations of indebtedness in such manner and subject to such limitations as may be provided by law;
6. Receive grants from any state or Federal agency or public or quasi-public body;
7. Adopt rules and regulations governing the Unit. Employ personnel, expend funds, and enter into contractual obligations.

SECTION 5.

LEVYING AD VALOREM TAXES WITHIN THE UNIT

Ad valorem taxes levied pursuant to this Ordinance shall be levied and a budget prepared and adopted by this Board after public hearing in the same manner as the Board prepares and adopts its annual county budget and levies taxes as provided by law. The levy of an ad valorem tax shall not exceed 3 mills per year.

SECTION 6.

RIVERDALE SHORES IMPROVEMENT FUND

There is hereby created a fund to be known as the Riverdale Shores Improvement Fund from which the cost of any municipal service may be paid, either in whole or in part. This fund shall contain all special charges, special assessments, taxes, interest, and other monies collected or otherwise obtained pursuant to this Ordinance or any subsequent Resolution thereto.

SECTION 7.

CONDITIONS PRECEDENT TO THE ACCEPTANCE OF THE
RECREATIONAL AND DRAINAGE FACILITIES WITHIN THE UNIT

It is hereby declared by the Board of County Commissioners that no ad valorem taxes will be levied pursuant to this Ordinance until the taxable year following the sale, transfer, and recording in the Public Records of Lee County, Florida of more than 280 lots within the Riverdale Shores Subdivision, a subdivision located within the unit, by U.S. Homes who is presently owner of record of all the lots within said subdivision provided, however, that the Board of County Commissioners shall not accept the recreational and drainage facilities nor approve the levying of ad valorem taxes unless the following conditions precedent are fulfilled:

1. The Lee County Division of Transportation and the Division of Community Services shall review the plans for the facilities to be established within the unit. Two plans shall be submitted to the Division of Transportation which shall either approve or reject the plan and return one copy to the developer. Two copies of the plan shall be submitted to the Division of Community Services which shall approve or reject the plan and return one copy to the developer.
2. After construction and prior to the levying of ad valorem taxes, the Lee County Division of Transportation and Division of Community Services shall again review the actual construction of the recreational and drainage facilities to assure compliance with the originally approved plan. The Lee County Division of Transportation and Division of Community Services must approve the acceptance prior to the public hearing to levy ad valorem taxes within the unit.
3. Title to all drainage easements and recreational facilities to be maintained by the County shall

... to the County in order legal form
prior to the public hearing on the levying of
ad valorem taxes within the unit. Such title
shall be submitted within reasonable time for
review by the Division of Transportation and
the County Attorney's Office.

No recreational or drainage facility shall be accepted by the
County without prior approval by the Division of Transportation
or the Division of Community Services.

SECTION 8.

SEVERABILITY

The provisions of this Ordinance are severable and it is
the intention to confer the whole or any part of the powers
herein provided. If any of the provisions of this Ordinance
shall be held unconstitutional by any court of competent
jurisdiction, the decision of such court shall not affect or
impair any of the remaining provisions of this Ordinance. It
is hereby declared to be the legislative intent that this
Ordinance would have been adopted had such unconstitutional
provision not been included therein.

SECTION 9.

ALTERNATE OR SUPPLEMENTAL AUTHORITY

This Ordinance shall not be construed as repealing or
superseding any other ordinance or law and is to be construed
as an alternate or supplemental authority for the exercise of
powers provided for herein.

SECTION 10.

EFFECTIVE DATE

This Ordinance shall become effective immediately upon
adoption and filing with the Secretary of State as provided
by Law.
