7. BACKGROUND:

In November of 2001, the Board of County Commissioners adopted the Communication Tower Interim Ordinance (Lee County Ordinance No. 01-20), while County staff moved forward with the assistance of communication tower consultants to develop and bring forward a Communication Tower Master Plan and Ordinance. The eight-month interim ordinance was extended in the Summer of 2002 for an additional 3-month period (Lee County Ordinance No. 02-21) to allow County staff and the consultant to complete work on the project. The project must now move forward on the above-recommended schedule of hearings to be presented to the Board of County Commissioners before the expiration of the interim regulations at the end of October.
