BACKGROUND: The developers of Miramar Outlets have requested a street name change for the portion of Corkscrew Road from I-75 to Ben Hill Griffin Parkway only be changed to a dual name as follows: CORKSCREW RD/ MIROMAR OUTLETS RD. Corkscrew Rd name would remain unchanged west of I-75 and east of Ben Hill Griffin Pkwy. No individual property owners would be affected by the change as Miromar owns the property abutting north and south of the Corkscrew Roadway as described in the O.R. book and pages.  Staff recommends denial of the street name change. The reason for the change is based on informing the public of the development's location by changing the identification signs on the Interstate to direct travelers in a safe manner. This reason does not meet the criteria for changing the street name to benefit the citizens of Lee County for the purpose of Public Safety (ie to reduce confusion and delays in response to 911 calls, duplication of street names, recent changes in physical street configuration.) Further, the request is contrary to the general principles of street naming established under ordinance #88-13 within the 9-1-1 Addressing Program. Policy # 8 of this ordinance states that "Any contiguous street shall have one name only and shall have the same name throughout the entire length." This proposed name change violates that policy.  MANAGEMENT RECOMMENDATIONS: Bring the matter to the BOCC for their consideration.
