7. BACKGROUND:

LARC is a non-profit organization dedicated to providing affordable housing for special needs populations in Southwest Florida. During 1999 the Lee County Affordable Housing Committee recommended and the Board of County Commissioners approved (Nov 16, 1999) awarding LARC \$131, 536.00 in SHIP funds for FY 2000/2001. On February 20, 2001 the Board of County Commissioners awarded LARC an additional \$40,000.00. These funds are to be used for the construction of a single-family home for 6 individuals with developmental disabilities. LARC has already purchased the land in Bonita Springs for this project.

The total SHIP award for the project is \$171,536. The terms of the award are spelled out in grant award agreements C-1591 and C-1699, which expire on December 31, 2002. LARC is requesting an extension of this deadline to May 30, 2003. LARC encountered delays during preparation of construction documents and specifications by their engineers.

Staff recommends that this extension be granted because: 1) it is in compliance with the SHIP rules and regulations and 2) it will ensure a timely completion of this project and fulfillment of the terms of the grant award agreement.

No additional SHIP dollars are required above those already granted.
