Subject: Veterans Parkway Limited Access Resolution

Lee County DOT is now seeking to designate Veterans Parkway from Santa Barbara to Pine Island Road and the Midpoint Memorial Bridge Corridor as a limited access facility in accordance with F.S. §338.01. Designation as a limited access facility will serve to maintain the integrity of the facility as an expressway. In accordance with F.S. §338.01, the attached resolution will serve to establish fixed access points and strictly limit the creation of any additional access points to only those necessary to serve the public interest. Additionally, any amendment to the resolution will require action by a super majority of the Board.

County staff recommends adoption of the resolution as a necessary step to preserve the public safety and traffic capacity provided by Veterans Parkway as designed and constructed.
