All eleven (11) Qualification Statements were considered at the Qualification Selection Committee meeting held on February 6, 2003. The Qualification Selection Committee (Voting) consisted of the following staff members: Jim Lavender, Director of Public Works, as Chairman, Ann Arnall, Human Services and Ayoub Al-Bahou, Project Manager. It was the consensus of the Committee that a "short-list" of Contractors should be invited for interview/presentations. The interview/presentations were held on February 13, 2003. On the basis of the information submitted by the Contractors in their Qualification Statements, and after conducting the interview/presentations with the "short-list" Contractors, the Committee agreed to recommend award to Brooks & Freund, LLC. A letter was received from Brooks & Freund, LLC on February 19, 2003, indicating a fee of seven percent (7%) of the total cost of the project.
