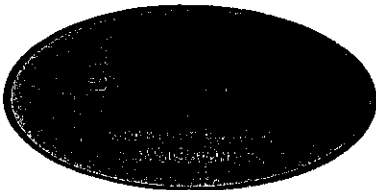
RESOLUTION
