Whereas: Laboratory medicine is an honorable profession, vital to sustaining a high standard of health care.

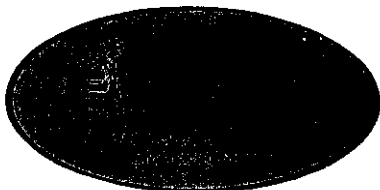
