On March 31, 2003, the Division of Purchasing received a request from Lee County Utilities to prepare a request to waive the formal quoting process – and accept four (4) quotes obtained on an informal basis – to purchase an IBM Model 810 server from Orcom at the competitively quoted best price of \$87,052.00. Utilities also requested that Board authority be obtained to expend the funds necessary for the annual maintenance and support costs for the life of the system (at current prices, annual maintenance costs would be approximately \$5,000.00). It was also requested by Utilities that Board approval be obtained for the expenditure of a not-to-exceed amount of \$5,000.00 for such incidentals as minor software, miscellaneous hardware, overnight delivery service, etc.

A bid waiver has been requested due to time constraints - Utilities has outgrown its present server and must have this larger server on-line as soon as possible to accommodate a continually growing customer base. With the server that is currently in place, routine processing has stretched from one hour to four; requiring staff to work overtime to wait for processing and reports.

SUBJECT: Blue Sheet to Waive Formal Bid

Our Customer Service area has outgrown the server on which our Orcom software resides. The server has become extremely slow, as our customer base has increased dramatically. In the very near future, we will be acquiring even more customers through the taking on of GES and additional plants located in some smaller communities some located in Pine Island. Currently, routine processing has stretched from one hour to four, causing our staff to work overtime, waiting on processing and reports.

The Model 810 has demonstrated a large improvement in batch processing times. The faster processing speed and additional disc space, provided by the Model 810, are needed to keep up with continued software enhancements and growth in the numbers of customers served in the Lee County and GES areas.

IBM discontinues the upgradability of the IBM AS400 Model 720 on October 8, 2003. After that date, the price will go up. Software support for the original SPD format adapters will be discontinued in 2 years, making an upgrade necessary.

It is our intention to purchase a new larger server as soon as possible.
