50 % of the connection fees have been paid.





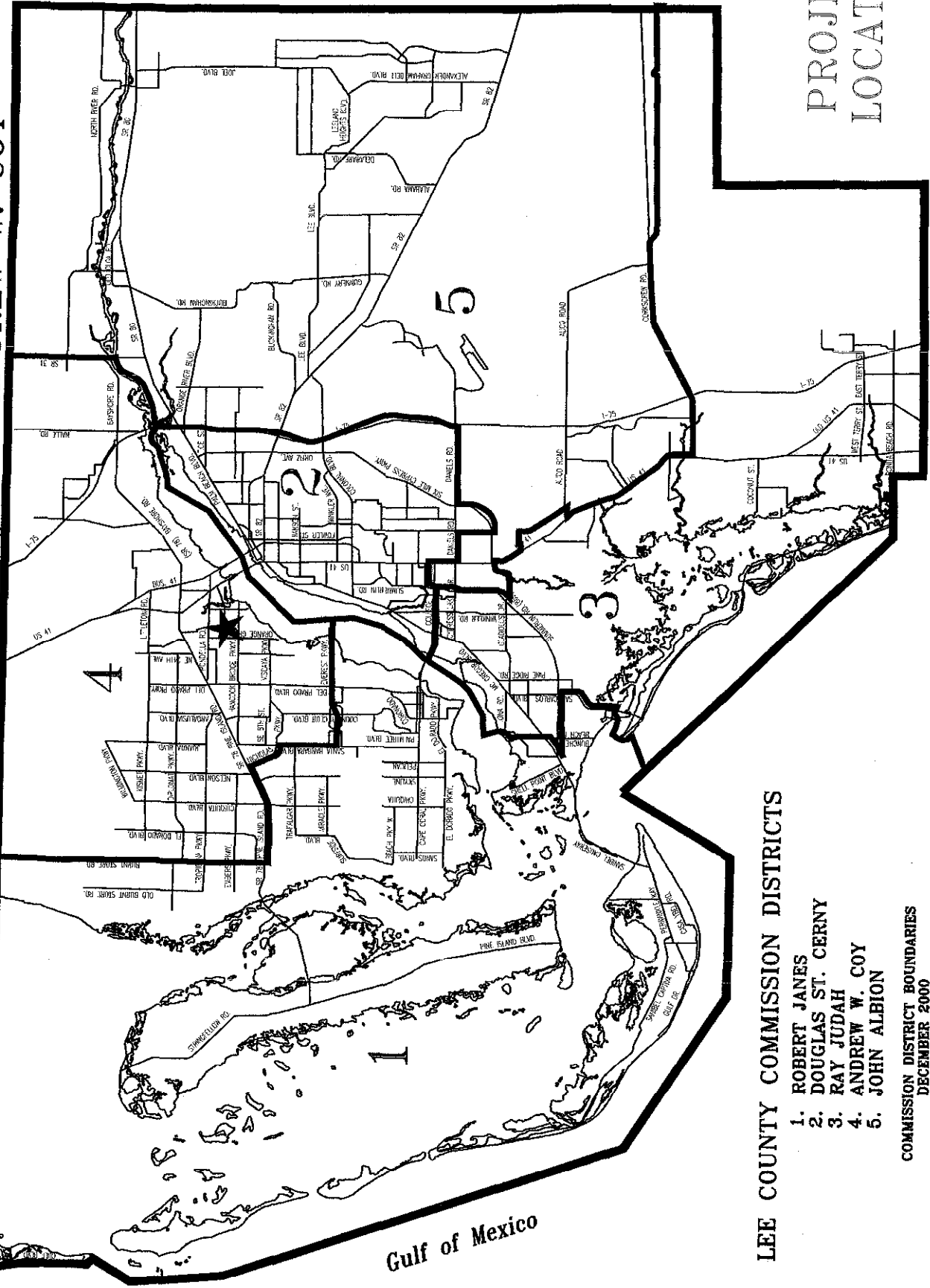
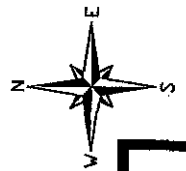
