**7. BACKGROUND:**

Lee County has been pursuing the expansion of the existing variable pricing program, which currently is limited to two axle vehicles to vehicles with three or more axles. This expansion is contemplated under a Value Pricing Grant obtained from FHWA to finance the implementation of the program and study the potential for improved traffic flow. Lee County has also been pursuing the ability to become interoperable with the State of Florida Electronic Toll Collection (ETC) system, SunPass.

To accomplish these objectives, it is necessary for the ordinance and resolution governing toll collection in the County to be modified to allow reduced tolls during variable pricing times for three or more axle vehicles, and to allow toll collection using SunPass ETC equipment.
