7. BACKGROUND: Lee County condemned 1.72 acres of land from Alico Mining, Inc. for construction of the airport's							
southerly drainage outfall. Through foreclosure, the land is currently owned by Jonbo Corporation. Lee County's first written							
offer was based on an appraisal of \$34,400 in 2000. Subsequent to that appraisal, the land to be acquired was encumbered by							
a conservation easement given to the South Florida Water Management District. Upon re-appraisal to factor the easement, Lee							
County's appraiser valued the 1.72 acres at \$8,600. A negotiated settlement of \$13,600 plus \$1,308 in attorney fees and costs has been reached. The difference between appraised value and settlement would be exceeded by litigation costs. The County							
Attorney recommends approval.
