The purpose of this memo is to request assistance in preparing approval for a bid waiver purchase of 9-1-1 proprietary software.

#### CAPE CORAL POLICE DEPARTMENT 9-1-1 CENTER CAD UPGRADE

**ACTION REQUESTED**: To approve a bid waiver for the purchase of software and licenses for 9 dispatch positions at the Cape Coral Police Department. The request is to waive the formal quotation procedure and for approval of funds not to exceed **\$99,000** from the 9-1-1 Wireless User Fee fund.

WHY ACTION IS NECESSARY: The software application is proprietary to the CAD vendor company OSSI. Requests for bid waivers and expenditures above \$50,000 require Board approval.

WHAT ACTION ACCOMPLISHES: This purchase will provide the mapping technology necessary to locate a cellular 9-1-1 caller. This action is in compliance with the FCC mandate to provide location technology for 9-1-1 cellular callers.

**BACKGROUND**: The Lee County 911 Program is responsible for the maintenance and operation of the 911 system and equipment throughout Lee County. The 9-1-1 Wireless User Fee is collected from all telephone users in Lee County and the funds are used in accordance with the rules and regulations of the 911 State Plan fs 365,171.

The Cape Coral Police Department has purchased a new computer aided dispatch (CAD) system from a reputable CAD vendor OSSI. Although all CAD vendors provide open software platforms, the software necessary to facilitate specific functions is always proprietary.

The BOCC has approved 911 Program funding in the past year for this technology to be integrated with the CAD systems of Lee Control (fire/EMS) and the Lee County Sheriffs Office 9-1-1 centers.

This project was a budget approved wireless fund item in the Fiscal Year 2004 budget proposal.

The customer would have to complete OSSI's "GIS Questionnaire" and OSSI would have to receive the Customer's GIS data for an evaluation to determine the final conversion costs.

NOTICE OF OSSI'S DEPENDENCY ON CUSTOMER'S GIS DEPARTMENT: OSSI's ability to provide conversion services relating to Geographic Information System (GIS) or relating to Maps or relating to geographic analysis, etc. is contingent on the Customer providing OSSI with the resources and data defined in OSSI's Visual CAD Map Resource Guide that is incorporated into this agreement as an Exhibit.

The Customer shall provide OSSI with the following accurate GIS resources and accurate data in an ASCII EOO format file for street centerlines containing:

- · Block ranges (address ranges are required)
- Street names
- · Street prefixes
- · Street suffixes
- Jurisdiction/City Code
- X/Y Coordinate Pairs for each street segment (referred to as ARCS by ARCINFO)

Customer is responsible for the accuracy of the street inventory and for the accuracy of all attribute data associated with street segments. Examples of such accuracy include:

- Missing streets
- Missing street segments
- · Missing intersections
- Errors in street names, street prefixes, street type, etc.

OSSI will return to Customer a list of the logical errors from OSSI's editing/data validation utility. This logical errors checked for include:

- · Address range undershoots
- · Address range overshoots
- · Missing street names
- · Missing street ranges

Customer is responsible to correct all errors and ensuring the accuracy of all GIS provided data.

All delays in the project caused by defects of data will be the sole responsibility of the Customer.

OSSI shall not assume any liability for any and all errors associated with the converted GIS resources.

The Customer is additionally responsible to digitize all required map layers to support the Public Safety GIS-based CAD and RMS subsystems.

The customer is responsible for the validation of all map line work, attribute information and related data as well as providing resources to field verify all of the GIS data.

OSSI can optionally provide services to convert the Customer's orthophoto and individual addresses information; however, they are not included in the base project.
