SETTLEMENT AGREEMENT

LEE COUNTY and KIRK BECK, Trustee, desire to amicably resolve the MSTBU Colonial Road Extension assessment and mutually agree as follows:

- 1. KIRK BECK, Trustee, has paid to LEE COUNTY \$91,437.94 to bring the principal and interest current for the Colonial Road Extension special assessment account for Strap No. 26+44-25-P4-00062,0000. This is in consideration of the Board's approval to waive 30% (\$6,716.89) of the accrued penalty amount of \$22,389.62. KIRK BECK agrees to pay the remaining penalty in the amount of \$15,672.73 within 30 days of execution of the Settlement Agreement.
- 2. If any future payments are not paid fully when due, LEE COUNTY may file a new action to collect and enforce its special assessment lien. Additionally, a 1% per month penalty for late payments shall apply to any outstanding balance. No future penalty waivers will be considered.

3. This agreement contains the entire agreement of the parties and may not be amended except in writing and duly executed by the parties.
