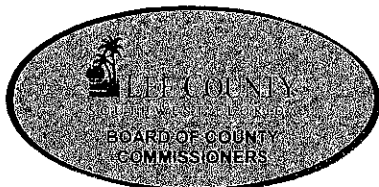
NOW, THEREFORE BE IT RESOLVED THAT THE Board of County Commissioners of Lee County, Florida does hereby proclaim November 2003 as


