- Whereas: Social workers, whether in direct practice, administration, education, research, or policy development make an impact in every community.

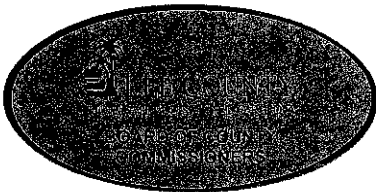
