BACKGROUND: A refunding opportunity has been identified for the Tourist Development Tax Revenue Bonds, Series							
1994. The Series 1994 Tourist Tax Refunding Bonds were issued on June 1, 1994. These bonds were a refunding of the original 1989 Series used to construct the Lee County Sports Complex.							
The Series 1994 bonds currently have \$8.2 million remaining with payments through 2016. The Series 1994 bonds would be fully refunded. <u>Present market conditions</u> indicate a possible overall savings of \$2.1 million (annually \$172,000) assuming no present value discount. The net present value savings is estimated to be over \$800,000 or above 10%.  Although market conditions will vary, there is a significant enough savings to pursue preparation of documents.  BOCC authorization to formally market the bonds on a competitive basis should be requested by May 2004.
