During the early stages of planning the Justice Center Expansion and bonding needs, the lease revenue from the Justice Center Annex (Sun Trust Building) was going to be used to fund some of the construction costs. Due to the uncertainty of the amount of lease revenue that will be received, it has been recommended that it is best to issue bonds at the full amount.

This financing is expected to be brought to the BoCC for authorization to competitively sell bonds in late April 2004.
