- Whereas: The Board of County Commissioners deems it altogether fitting and proper to promote education and awareness of fair housing laws.

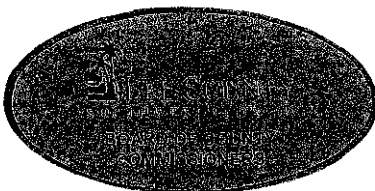
**NOW, THEREFORE BE IT RESOLVED THAT THE Board of County Commissioners of Lee County, Florida, does hereby designate April 2004 as**
