As you can see, 019282 is twice the CPM in Maint & Repairs and almost twice the total CPM. This unit also only has about 1/3 the number of mileage as the other 12-yard dump trucks. The down time is also above average and by replacing this dump truck now, our total numbers should go back to normal.

Six of these dump trucks were replaced back in 2001. 019282 was the only one not replaced due to funds available. Now that the funds are available, we need to replace the truck so our averages for this class code will decrease. 019282 is also the only Ford in this class of trucks.

019282 has a total down time of 530.76 hours in the past two years. Our standard down time for the rest of same dump trucks is 415.13.
