- Whereas: The Harry Chapin Food Bank of Southwest Florida will distribute the food to over 170 agencies that feed people in need.

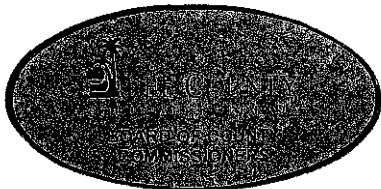
