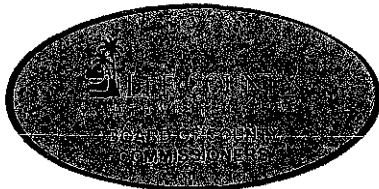
Whereas: Meg Geltner's dedicated service has benefited our local community immensely by creating a better quality of life for others; and
