**1. REQUESTED MOTION:**

**ACTION REQUESTED:**

Approve the purchase and transfer of federal interest on four (4) 1999 Trolley Buses from Sarasota County to LeeTran and allow the Chairman to execute the required documents necessary to complete the sale and transfer.

**WHY ACTION IS NECESSARY:**

Board approval and acceptance is required to complete the purchase and transfer of the trolleys from Sarasota County to LeeTran. Board approval is required for expenditures in excess of \$50,000.

**WHAT ACTION ACCOMPLISHES:**

This action allows LeeTran to purchase four (4) 1999 Trolley Buses from Sarasota with the remaining useful life at a cost of \$13,385.00 each, \$53,540.00 total. The purchase will be covered under a pending federal grant for the remaining federal interest of \$481,860.00.

**7. BACKGROUND:**

Sarasota County has agreed to transfer four (4) 1999 Trolley Buses to LeeTran for the balance of the remaining local share on the vehicles, estimated at \$13,500.00 each. The Sarasota Board of County Commissioners at their April 28, 2004 meeting approved the sale and transfer of the vehicles. These trolleys have low mileage and a useful life of 10 years and will serve as needed replacement vehicles for trolleys in the LeeTran fleet. These buses have a federal interest, which will transfer with the vehicles. The purchase price of approximately \$535,400.00 will be included in a federal grant for \$481,860.00 with the required local match of \$53,540.00

Funds have been budgeted in KI5440148640.506430 (Independent Div., Transit, Fixed Route, Capital Fund, Vehicle & Rolling Stock)
