AGREEMENT FOR TOURIST DEVELOPMENT TAX FUNDING

THIS AGREEMENT is entered into by and between LEE COUNTY, a Charter

County and a political subdivision of the State of Florida, hereinafter referred to as the

"COUNTY" and the CITY OF BONITA SPRINGS, a municipality incorporated in the State

of Florida, hereinafter referred to as "RECIPIENT", for funding provided by Lee County

pursuant to its Tourist Development Plan.

WITNESSETH:

WHEREAS, pursuant to Florida Statutes §125.0104 and Lee County Ordinance No.

03-18, Lee County collects tourist development tax; and

WHEREAS, COUNTY and RECIPIENT acknowledges that the tourist development

tax may only be spent in accordance with the Tourist Development Plan adopted by Lee

County; and

WHEREAS, the COUNTY has approved the RECIPIENT'S request for funding

under its Tourist Development Tax Plan for implementation of the following project:

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

1. The COUNTY, through the Tourist Development Council (TDC) has

allocated a total of \$620,000.00 toward this Project. Of which \$305,000.00

was originally awarded in fiscal year 2002. This Agreement addresses the

- additional amount not to exceed \$315,000.00 awarded by the TDC in February and March 2004.
- 2. The TDC will contribute an amount not to exceed \$105,000.00 to the project immediately. The COUNTY will then refund the RECIPIENT for the amount not to exceed \$105,000.00 during the COUNTY'S fiscal year 2005 and an additional \$105,000 during the COUNTY'S fiscal year 2006.
- 3. For this project the **RECIPIENT** will provide the **COUNTY** with funds in the amount of \$320,000. Of this \$320,000, the **RECIPIENT** is contributing \$80,000.00; advancing the **COUNTY** \$210,000, to be refunded as described above; and providing the **COUNTY** with private donations received in the amount of \$30,000. Based on a presentation before the TDC, it is understood that the rest of the funding for this Project will be contributed by the State of Florida in the amount of \$100,000.00 and Lee County Department of Transportation in the amount of \$70,000.00.
- 4. The RECIPIENT covenants to the COUNTY that it has lawful authority to enter into this agreement and has authorized the execution of this agreement by its authorized representative.
- 5. This agreement may not be modified, amended or extended orally. This agreement may be amended only by written agreement executed by the governing bodies of both parties.
