to families separated by violence and abuse at the Lee County Extension Service and other locations. Educational information is then accessible to parents through the University of Florida Extension Service.									
Lee County received reimbursement for services through annual grants from the Department of Children and Families for children in its dependency system, as well as a lesser amount, from fees paid by parents whose children are not in foster care. Lee County managed this
