WHEREAS, the Project Number LC-04-04-01 is a company seeking to expand in Lee County; and

WHEREAS, Project Number LC-04-04-01 is one of the County's target industries to diversity the economy, that offer higher-wage jobs and specialized training; and

WHEREAS, Project Number LC-04-04-01 will employ 140 with an annual wage of 150% of the Lee County average wage and the economic impact of this project in Lee County will be \$15.3 million in wages and benefits annually and create 69 indirect jobs; and

WHEREAS, The Board of County Commissioners approved a \$1.5 million incentive program for FY 2003/04 which included participation of the 20% local match required by the State of Florida for a company to be considered for state inducement incentives. It is acknowledged and understood that Lee County desires to provide this local participation in the State program;
