

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU), made and entered into this ____ day of _____, 2004, by and between LEE COUNTY, a political subdivision of the State of Florida, hereinafter referred to as the "County" and the FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION, hereinafter referred to as the "Commission".

WITNESETH:

WHEREAS, the County, and Commission share an interest in issues that effect the boating community; and

WHEREAS, the County, and Commission recognize that the ability to go boating is dependent upon the ability to access the waterways; and

WHEREAS, the County and Commission endeavor to provide safe and enjoyable boating for the people of Florida and its visitors through the effective and coordinated management of our waterways; and

WHEREAS, the County, and Commission work to formulate the best solutions possible without jeopardizing our natural resources or our freedoms to navigate; and

WHEREAS, the ability to make sound decisions is dependent upon having comprehensive data and analysis; and

WHEREAS, the County, and Commission recognize that completion of a comprehensive recreational boating facility inventory in Lee County (hereinafter the "Project") would allow for proper planning of boating access facilities; and

WHEREAS, it is in the interest of the public health, safety and welfare of the County and the Commission to cooperate in the completion of the Project; and

WHEREAS, the County, and Commission agree to cooperate to complete the Project; and

WHEREAS, Lee County has budgeted non-federal funding to contribute toward a share of the Project costs: and

WHEREAS, the Commission agrees to use available state and federal matching funds to contract for the completion of the Project, and

WHEREAS, it is understood that this Project is a small part of a larger effort by the Commission to complete a similar inventory for the entire State of Florida.

NOW THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, the County, and the Commission agree as follows:

SECTION ONE: PURPOSE AND SCOPE

- A. The purpose of this MOU is to define the obligations of the Commission and the County in completing the Project. All terms and conditions of this MOU will be interpreted in a manner consistent with and in furtherance of the purpose as set forth in this Section.
- B. For the purpose of this MOU, the Project is defined as a comprehensive inventory of Lee County boating access facilities to include both the freshwater, saltwater and brackish environments. These facilities shall include: boat ramps, marinas, dry storage, mooring fields and docks. The inventory shall include GPS location (latitude and longitude) of all facilities, as well as the specific measuring variables identified within the attached Request for Proposal (Exhibit 1). The Project is inclusive of all tasks to complete the work including, but not limited to, soliciting bids, selecting a Contractor to complete the Project, overseeing the

Contractor through Project completion, and providing for payment, accounting and deliverables.

SECTION TWO: OBLIGATIONS OF THE COUNTY

Under the terms of the MOU, the County will:

- A. Review and comment on the Request for Proposal.
- B. Participate with the Commission in the selection of the Contractor.
- C. Where reasonably possible and applicable to Lee County areas, exempt or obtain any necessary County permits that are necessary for the completion of the Project.
- D. Review and comment on draft work products throughout the Project period.
- E. Contribute funding in accordance with Section Four of the MOU.

SECTION THREE: OBLIGATIONS OF THE COMMISSION

Under the terms of this MOU, the Commission will:

- A. In cooperation with the County, complete the Project Scope of Work and issue a Request for Proposals.
- B. Allow the County the opportunity to participate in every aspect of the Project.
- C. Inform the County, in writing, of any change in the Project costs, sources of funding for the Project and use of Project funds during prosecution of work on the Project.
- D. Be responsible for the selection and oversight of the Contractor.
- E. Keep books, records, documents and other evidence pertaining to costs and expenses incurred for the construction to the extent, and in such detail, as will

- properly reflect total Project costs. The Commission will make available, at its office at reasonable times, such books, records, documents and other evidence for inspection and audit by authorized County representatives.
- F. Notify the County of the satisfactory completion of the Project, and provide a certification of final Project costs.
- G. Provide the County with final paper and digital copies of the Project deliverables.

SECTION FOUR: COST ALLOCATION

- A. The County will contribute the first \$100,000 from non-federal funding sources.
- B. The Commission will contribute the remaining Project costs up to a maximum of \$300,000.
- C. Any change in the cost allocation shall only be by written amendment to thisMOU executed by both parties.
- D. The CONTRACTOR shall submit completed invoices along with a progress report to the Commission. The Commission will certify that the invoices are accurate and in accordance with the terms of this MOU and the approved budget. Certified Invoices shall be forwarded by the Commission to the County no more frequently than monthly and for completed work only for invoices pertaining to the funds contributed as agreed hereto by the County. The County shall remit to the CONTRACTOR within thirty (30) days the entire invoice amount up to the total amount specified in Section Four of this MOU. Thereafter, the Commission will process all invoices in accordance with S. 215.422, Florida Statutes.

E. The Commission's obligation to perform under this MOU is subject to the availability of funds and contingent upon an annual appropriation by the Legislature.

SECTION FIVE: LIABILITY

- A. To only the extent as permitted by Florida Law, in particular, §768.28, F.S., the County shall hold the Commission harmless from and against any and all liability, actions, claims and damages arising after the commencement of the term of this MOU which may be imposed upon or asserted against the Commission by reason of the claim of any person for damage(s) to persons or property occurring as the direct result of the County's negligent acts or omissions as outlined in this MOU. The County shall have the right to contest the validity of any and all such claims and to defend, settle and compromise such claims of any kind or character in the name of the Commission, and as the County may deem appropriate, provided that the expense thereof shall be paid by the County. Notwithstanding the above, the County shall not be liable to in any manner, nor be required to hold the Commission harmless, for any of the Commission's own negligent acts or omissions.
- B. To only the extent as permitted by Florida Law, in particular, §768.28, F.S., the Commission shall hold the County harmless from and against any and all liability, actions, claims and damages arising after the commencement of the term of this MOU which may be imposed upon or asserted against the County by reason of the claim of any person for damage(s) to persons or property occurring as the

direct result of the Commission's negligent acts or omissions as outlined in the MOU. The Commission shall have the right to contest the validity of any and all such claims and to defend, settle and compromise such claims of any kind or character in the name of the County, and as the Commission may deem appropriate, provided that the expense thereof shall be paid by the Commission. Notwithstanding the above, the Commission shall not be liable to in any manner, nor be required to hold the County harmless, for any of the County's own negligent acts or omissions.

C. The Parties further agree that by execution of this MOU, no Party will be deemed to have waived its statutory defense of sovereign immunity, or increased its limits of liability as provided for in §768.28, Florida Statutes.

SECTION SIX: NOTICES

SECTION SEVEN: PUBLIC ACCESS TO RECORDS

The County and Commission acknowledge that all documents regarding the Project, as well as all of the documents, papers, letters or other material prepared and completed,

made or received in conjunction with this MOU, are subject to the public records provisions of Florida Statutes and shall be maintained and made available to the public.

SECTION EIGHT: TERM

The term of the MOU will be for one (1) year from the date of execution, subject to the cancellation provisions as hereinafter enumerated, or upon full performance by the Parties hereto with respect to the terms, conditions, requirements and mutual obligations herein, whichever first occurs. Provided, however, that this MOU may be extended thereafter in writing pursuant to terms and conditions mutually agreeable to the Parties.

SECTION NINE: CANCELLATION OF THE MOU

Either Party may cancel this MOU at any time. Any costs incurred with this Project prior to a cancellation after a Contractor has been selected will be borne by the Party canceling the project. The Party canceling the project must give by certified mail sixty (60) days written notice of its intention to cancel the Project.

SECTION TEN: RECORD KEEPING REQUIREMENTS

The County and the Commission shall maintain accurate books, records, documents and other evidence that sufficiently and properly reflect all direct and indirect costs of any nature expended in the performance of this MOU, in accordance with generally accepted accounting principles. The County and the Commission shall allow each other, the State, or other authorized representatives, access to periodically inspect, review or audit such documents as books, vouchers, records, reports, canceled checks and any and all similar material. Such audit may include examination and review of the

source and application of all funds whether from the state, local or federal government, private sources or otherwise. These records shall be maintained for five (5) years following the close of this MOU.

SECTION ELEVEN: AMENDMENTS

This MOU may only be amended in writing duly executed by the Commission and the County.

SECTION TWELVE: NON-DISCRIMINATION

No person, on the grounds of race, creed, color, national origin, age, sex, or disability, shall be excluded from participation in, be denied the proceeds or benefits of, or be otherwise subjected to discrimination in performance of this MOU.

SECTION THIRTEEN: SEVERABILITY AND CHOICE OF VENUE

This MOU has been delivered in the State of Florida and shall be construed in accordance with the laws of Florida. Wherever possible, each provision of this MOU shall be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this MOU shall be prohibited or invalid under applicable law, such provision shall be ineffective to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this MOU. Any action in connection herewith, in law or equity, shall be brought in Leon County, Florida.

SECTION FOURTEEN: NO THIRD PARTY RIGHTS

The parties hereto do not intend nor shall this MOU be construed to grant any rights, privileges or interest to any third party.

SECTION FIFTEEN: JURY TRIAL WAIVER

As consideration of this MOU, the parties hereby waive trial by jury in any action or proceeding brought by any party against any other party pertaining to any matter whatsoever arising out of or in any way connected with this MOU.

SECTION SIXTEEN: PROHIBITION OF DISCRIMINATORY VENDORS

In accordance with Section 287.134, Florida Statutes, an entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity.

SECTION SEVENTEEN: ENTIRE AGREEMENT

This MOU with all incorporated attachments and exhibits represents the entire agreement of the parties. Any alterations, variations, changes, modifications or waivers of provisions of the MOU shall only be valid when they have been reduced to writing, and duly signed by each of the parties hereto, unless otherwise provided herein.

Introduction

The Florida Fish and Wildlife Conservation Commission (FWC), Division of Law Enforcement, Office of Boating and Waterways, herein after called "Commission", is seeking sealed proposals to provide a comprehensive statewide recreational boating facilities inventory for the State of Florida (inclusive of the entire universe of recreational boating access facilities). The inventory will include all counties of the state (coastal and inland) and includes saltwater, freshwater and brackish boating access. While there are databases (some from the government sector and some from the private sector) that identify this type of recreational boating access facilities inventory, the general consensus is that a comprehensive statewide recreational boating inventory, accessible by the public and private sectors, available within a unilateral database application, does not exist. Additionally, the Commission, in order to properly plan for boating access facilities for the state requires knowledge of these facilities consistent with a statewide comprehensive inventory.

The recreational boating access facilities inventory is Phase I of a multiphase project. The second phase (Phase II) of the project is designed to MAP existing recreational boating access facilities using data from Phase I consistent with GIS applications. The third phase (Phase III) of the project is designed to provide an estimation of the present and projected demand (through 2020) and supply of recreational boating facilities statewide (utilizing a peak demand model), develop use profiles of current facilities, project where future boaters will come from and what facilities they will use, identify what capital costs will be necessary to meet future access demand and determine on-the-water boater destinations. The final phase of the project (Phase IV) is designed to develop a prioritization scheme for the placement of new boating access facilities or the rebuilding of existing boating access facility infrastructure. Phase IV will include economic considerations within the decision model including economic impact and economic value considerations.

Purpose of the Proposed Project

The purpose of the proposed project (**Phase I**) is to provide a statewide comprehensive boating access facilities inventory that is inclusive of the entire universe of boating access facilities statewide. The inventory shall include saltwater, freshwater and brackish environments. These facilities that are defined herein in the Definitions Section shall include:

Marinas
Dry Storage
Mooring Fields
Boat Ramps
Docks

The information secured from the inventory shall be placed in a computer database and be made available for electronic access by the government, public and interested parties.

Background

It is currently estimated that there are upwards of 8,000 boat ramps within the state (Florida Department of Environmental Protection, 2000). However, *exact figures are unknown*. Many ramps are unavailable for public use and limited to their owners or members of private marinas boat and yacht clubs. Within the public arena, there are an estimated 1,300 ramps statewide operated by public agencies for public use (Florida Marine Research Institute, 2000).

While the population of Florida is more concentrated along the southeast coast and what is commonly referred to as the I-4 corridor (the area of central Florida located along U.S. Interstate 4), the pattern of boat ownership and location of ramps is somewhat different. Recreational boat ownership per capita in the northern part of the state is nearly twice that of either central or southern Florida. This comes in spite of the more numerous waterways and abundance of lakes in central Florida and the easy saltwater access of the Florida Keys. Yet, the known distribution of public ramps is fairly uniform between the northern and central regions of Florida, with the southern region containing less than a quarter of the state's ramps. This may be due in part to the large number of private marinas and yacht clubs in southern Florida, particularly in Dade, Broward and Palm Beach counties (Assessing the Economic Value and Impact of Florida's Public Piers and Boat Ramps, Florida Fish and Wildlife Conservation Commission, 2001).

The Florida Department of Environmental Protection (DEP) lists 994 marinas located throughout the state. DEP is currently surveying marinas to update the list.

Scope of Work Phase I

The Commission is seeking proposals from contractors that can provide labor and equipment to conduct a comprehensive recreational boating facilities inventory for the State of Florida. The following facilities shall be included in the inventory: marinas, dry storage, mooring fields, boat ramps and docks. This inventory shall include all counties of the state (inland and coastal) and shall include both saltwater, brackish water and freshwater environments. A prime responsibility of the contractor (for Phase I) will be to ascertain an accurate count of these facilities statewide and provide an accurate latitude and longitude GPS location as defined of these facilities in the freshwater, saltwater and brackish environments. The contractor will supply complete metadata consistent with the Federal Geographic Data Committee's (FGDC) Content Standard for Digital Geospatial Metadata. The Contractor will also provide a method for the dynamic maintenance and upkeep of the developed inventory data set. Definitions:

Anchorage - An area set apart for anchored vessels in a harbor.

Boat Ramp - A graded and surfaced slope consisting of one or more launching lanes constructed of concrete, timber, or asphalt, which is extending from the shoreline into the body of water and partially above and below the water surface. It is designed to accommodate launching or retrieving a boat from or to a trailer.

Brackish Water Facility – A facility located in a body of water influenced by tidal fluctuations and ultimately accesses one of the major saltwater bodies of water such as the Intercostal Waterway, Atlantic Ocean or Gulf of Mexico. Additional designation to brackishwater facility will be the distance to and name of the major saltwater body of water it accesses.

 $\mathbf{Dock}-\mathbf{A}$ dock means a fixed or floating structure, including access walkways, terminal platforms, catwalks, mooring pilings, lifts, davits and other associated water-dependent structures used for mooring and accessing vessels.

Dry Storage – a boat storage or parking space, whether covered or uncovered, at a marina or other place where boats are moored for the purpose of storing boats on land between use and includes provisions to transfer to and from the water by mechanical means upon request. A facility located within a freshwater environment such as a lake, river, channel, canal or lagoon with direct access to predominately freshwater areas.

GPS Format – GPS internal settings are WGS 84, Latitude/Longitude, Wide Area Augmentation System (WAAS) real time differential correction. The U.S. Coat Guard Beacon System is acceptable for correction. Contractor must maintain digital custody of the data. Data created by the GPS unit must be stored and downloaded, maintaining its digital format. No manual transcription.

For use in GIS, points must have a detailed naming convention and unique identifier. We request these export settings from GPS: ESRI shapefile in <u>documented</u> projection (c.g., State Plane, UTM, Albers) and specified units (meters, feet, geographic).

Marina – "Marina" means a licensed commercial facility which provides secured public moorings or dry storage for vessels on a leased basis.

Mooring Fields - An area containing an organized array of fixed point moorings and that is set aside for the mooring of vessels, within which the anchoring of vessels, as distinguished from the attachment to the fixed point moorings, is discouraged or prohibited.

Saltwater Facility - A facility located in a marine environment such as a bay, channel, canal or harbor with direct access to the Intercoastal Waterway, Atlantic Ocean or Gulf of Mexico.

The proposal must describe, in detail the method or methods used to achieve the stated **Objectives** and **Intended outcome** of **Phase I** of the project as stated herein.

Each proposal must include a PROJECT PLAN. The project plan must include a Schedule of <u>Deliverables</u> that specifies:

- 2. Proposed dates for submission of each deliverable Methods and standards to be employed
- 3. Costs of each deliverable

The Proposer must develop task and management plans and a fee schedule to explain in detail how the project plan (for Phase I) for implementing and administering a program to assess Florida's recreational boating access facilities will be implemented.
