7. BACKGROUND:

The Department of Transportation submitted a request to Contracts Management to obtain bids for the Laurel Drive Sidewalk Improvements. The expected cost of the widening of lanes required the use of the formal sealed bid procedure.

On the bidding deadline of May 26, 2004, Contracts received five (5) bids. The bids have been reviewed by the Consultant, Wilson Miller and by the Department of Transportation and it is being recommended that award be made to the lowest responsive/responsible bidder, Gulf Paving Co., Inc., for the not-to-exceed amount of \$816,667.85, with a final project completion time of 210 calendar days.
