**7. BACKGROUND:**

In accordance with Lee County Ordinance, 88-13, the Enhanced 9-1-1 Telephone System Program Manager shall recommend approval for street name changes of existing plats within the unincorporated areas of Lee County. The 9-1-1 Addressing Program previously proposed an address change to correct a house numbering error, which has existed for the past 30 years. The reason for this action is an effort by the County to prevent any possible delays in service by police, fire and EMS responders as a result of the existing irregular numbering system. A petition presented by a number of residents of Bethany Ct requested the aforementioned street name change thus leaving the house numbers unaffected. The street name modification minimizes the effect on the residents by allowing the residents to maintain their current house numbers. This design has been successful in other areas of the county and has been endorsed by the Lee County 9-1-1 Program.
