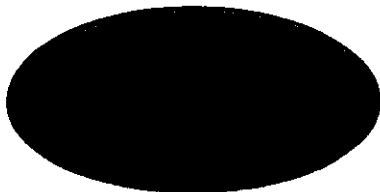
RESOLUTION
