1. REQUESTED MOTION:

ACTION REQUESTED: Authorize the scheduling of a public hearing for Tuesday, October 12, 2004 at 10:00 a.m., during the regular Board Meeting to discuss the use of funds related to the Local Law Enforcement Block Grant.

WHY ACTION IS NECESSARY: A public hearing and the use of the Advisory Board to make non-binding recommendations for the use of the funds are required as part of the Local Law Enforcement Block Grant application process. The County must hold a hearing prior to obligation of the funds. Due to time constraints, advertising was done on September 10, 2004.

7. BACKGROUND: The Local Law Enforcement Block Grant is part of the Fiscal Year 1998 Omnibus Appropriations Act of the Federal Government. Lee County has applied for a direct award of \$91,691 with a required cash match of \$10,188. Matching funds will come from the Sheriff's 04/05 general fund budget request.

An advisory board must be established to review the application and make non-binding recommendations on the use of the funds. On July 3, 1996 the Board of County Commissioners appointed the Coalition for a Drug Free Lee County to serve as the advisory board for the grant, their recommendation will be provided prior to the public hearing date.

At least one public hearing must be held regarding the proposed use of the funds prior to obligation.
