1. <u>REQUESTED MOTION</u>:

**ACTION REQUESTED:** Approve Project # PB040678, for the Parks and Recreation Department, for the utilization (piggyback) of Collier County Proposal # RFP 01-3236, which has gone through their competitive bidding process, for Fitness Equipment and was awarded to Berry's Barbells and Equipment Inc., for the prices as listed on their proposal. The initial quote term was for three years from 7/31/01 to 7/30/04, and was renewed for an additional one-year period through 7/30/05. Also request permission to continue this piggyback if Collier County renews the contract again. For general information, the Parks and Recreation Department estimates spending no more than \$300,000 for fitness equipment over the next two years.

WHY ACTION IS NECESSARY: Board approval is required because this expenditure will exceed \$50,000.

<u>WHAT ACTION ACCOMPLISHES</u>: Allows the Parks and Recreation Department to purchase fitness equipment in a cost effective, efficient, and timely manner.

This Public Notice was posted in the lobby of the Purchasing Building, Collier County Government Center on May 11, 2001.

### SCOPE OF SERVICES

The purpose of the Request for Proposal (RFP) is to establish an agreement with one or more vendors to furnish, deliver and install fitness equipment on an as needed when needed basis for a period of three (3) years.

Part of this RFP will be the purchase of equipment for the North Naples Regional Park Fitness Facility. The facility will be six thousand (6,000) square feet in size. Equipment for this facility will be purchased in approximately summer of 2003.

### **Description of Equipment**

All equipment offered must be **commercial grade** product. Home and institutional type equipment is not acceptable. **Equipment offered shall be top of the line, high quality, commercial grade equipment.** The type of equipment that may be required is as follows:

- Free Weights and Benches
- Plate Loading Equipment
- Selectorized Equipment
- Cardiovascular Equipment

### **Equipment Description**

The Proposer shall provide a full description of the fitness equipment proposed to include manufacturer name, weight of equipment, dimension requirements, power requirements, physical properties, performance characteristics, finish and intended use of equipment.

### **Testing of Equipment**

As a part of the selection process, each Proposer shall be required to arrange for the Selection Committee to visit a location where the proposed equipment is set up. The site proposed for the Selection Committee to visit shall be within a radius of two (2) hours from Naples.

There shall be at least one piece of equipment setup for demonstration purposes from each of the categories listed above (see Description of Equipment). Members of the Selection Committee will use and operate the equipment. The Selection Committee will evaluate the equipment on ease of use, feel, alignment, design, reliability, appearance and quality/fit. The Selection Committee will make the determination as to acceptability of the equipment offered and will either accept or reject equipment based on established criteria during this phase of the process (Evaluation Criteria #1 and #4).

### **Evaluation Criteria**

Only proposals deemed acceptable during the testing of equipment phase will be evaluated and ranked according to established criteria outlined on page nine (9) of this RFP (Evaluation Criteria #2, 3, 5 and 6).

### Warranty

The warranty period shall begin on the date of acceptance of the equipment by the County. Each Proposer shall provide a description of what the supplier or the manufacturer of the fitness equipment is prepared to fix without charge, and likewise, what is not covered under the warranty. This shall also include the warranty duration cycle for pads, cables, parts and motors.

### Proposed Training

The Proposer shall provide full description of training that will be provided for staff (to include the type of training and number of hours proposed).

### **Delivery**

The Proposer shall indicate the total number of days for delivery to be made. The equipment delivered under this RFP shall remain the property of the seller until a physical inspection and actual usage of the equipment is made and thereafter accepted to the satisfaction of Collier County.

### Assembly and/or Placement

All equipment must be completely assembled prior to acceptance by Collier County. Space shall be provided for on-site assembly for convenience of Awardee(s). It shall be the responsibility of the Awardee(s) to supply necessary labor for the placement of all equipment as specified. All items are to be fully set up and installed, operational and demonstrated by successful vendor's personnel at time of delivery.

### <u>Debris</u>

The Awardee(s) shall be responsible for the prompt removal of all debris associated with setup and installation of the equipment.

### **Terms of Agreement**

The resulting Agreement shall be in effect for a period of three (3) years, beginning with the date of approval by the Board of County Commissioners.

### **Contract Renewal**

The County retains the right to renew this contract, with the consent of the vendor, under the same terms and conditions for one (1) additional year.

### **Special Note:**

Collier County Government, is a member of the SW Florida Purchasing Consortium. It is hereby made a part of this Invitation to Bid that the submission of any bid in response to this publicized request constitutes a bid made under the same conditions, for the same contract price, to the other members of the said Consortium.

### Vendor Performance Evaluation:

Collier County has implemented a Vendor Performance Evaluation System for all contracts awarded in excess of \$25,000. To this end, vendors will be evaluated on their performance upon completion/termination of agreement.

### Price Adjustment

All prices offered herein shall be firm against any increase for one hundred eighty (180) days from effective date of this proposed agreement. After this date, it shall be the vendor's responsibility to notify the Purchasing Department ten (10) days in advance of any anticipated changes in prices and submit a request for price increase by furnishing bona-fide manufacturer's documents or price lists reflecting the changes. Increases shall be limited to the actual cost increase to the vendor. Percentage discount on approved contract shall remain in effect for the entire Contract period.

### New Product Lines

During the Contract period new product lines may be added; however, the vendor will be required to submit in writing all appropriate information and meet the requirements of this RFP. The request shall be submitted to the Director of Parks and Recreation for final review and approval.

### **Discontinuance of a Product Line**

During the Contract period should the vendor be unable to provide an approved product line for any reason, the vendor shall immediately in writing notify the Director of Parks and Recreation. The County shall have the right to obtain an alternate vendor for the approved product line.

### Proposer's Qualifications:

- 1. All Proposers must be primarily engaged in providing the services as outlined in this proposal and must have been in the business of furnishing, delivering and installing fitness equipment fore three (3) years.
- 2. The Proposers shall have a proven record of having successfully provided this service requirement on at least two (2) previous occasions.
- 3. The County reserves the right to check all references furnished and consider the responses received in determining the award of this proposal.
- 4. The Proposer's personal and management to be utilized in this service requirement shall be knowledgeable in their areas of expertise. The County reserves the right to perform investigations as may be deemed necessary to ensure that competent persons will be utilized in the performance of the Contract.

### **Proposal Submittal:**

In responding to this proposal, each proposer shall include within a 20-page limit (total for the entire submission).

- 1. Proposer's Credentials: Proposers shall provide, in detail, their credentials in the area of furnishing, delivering and installing fitness equipment and any information which documents successful and reliable experience in past performance, especially those performances related to the requirements of this RFP. Include a description of the Proposer's business history and number of years in operation. Related experience shall be restricted to those assignments undertaken within the last five (5) years.
- 2. Staff Credentials: The Proposer shall include the name, title, address and telephone number of persons who will be assigned to perform services under the proposal.

- 3. References: A list of three (3) applicable customer references is to be provided who have contracted for similar services offered by the Proposer, which is considered identical or similar to the requirements of this RFP. Failure to do so may be cause for rejection of the Proposal. The list shall include:
  - a. Company name and address;
  - b. Contracting Officer, telephone number and e-mail address
  - c. Technical representative, telephone number and e-mail address; and
  - d. A brief, written description of the specific award.
- 4. Warranty Information: As described on page four (4) of the Scope of Services.
- 5. Training Information: As described on page four (4) of the Scope of Services.
- 6. Cost Proposal: Proposed pricing for all equipment offered must be detailed. This shall include, but not be limited to, the fitness equipment itself, installation, training, on-going support (maintenance) and warranty. The Proposer shall be required to provide a catalog to include a price list and the Proposer shall offer a percentage discount off of price list. The price list provided and the percentage discount offered shall remain if effect for period of three (3) years.

### Supplemental Information

- 1. Statement of litigation that firm or staff is currently involved in, or has been involved in over the past five (5) years, stating points of contention and results if available.
- 2. Proposer Qualification Form.
- 3. Insurance Requirements Certification.
- 4. Proposer's Checklist.

Licenses: The Contractor, at time of proposal submittal, shall possess the correct occupational licenses, all professional licenses or other authorizations necessary to carry out and perform the work required by the project pursuant to all applicable Federal, State and Local Laws, Statute, Ordinances, and rules and regulations of any kind. Copies of the licenses should be submitted with the proposal indicating that the entity proposing as well as the team assigned to the County account is properly licensed to perform the activities or work included in the contract documents. The vendor shall be licensed to operate within Collier County.

### **Evaluation Criteria**

Collier County procedure for selecting is as follows:

- 1. The County Manager shall appoint a Selection Committee to review all proposals submitted.
- 2. Request for Proposals
- 3. Subsequent to the closing of proposals, the Purchasing Agent and Project Manager shall review the proposals received and verify whether each proposal appears to be minimally responsive to the requirements of the published RFP. Should both the Purchasing Agent and Project Manager be appointed to the committee as voting members, such meetings shall be open to the public and the Purchasing Agent shall publicly post prior notice of such meeting in the lobby of the Purchasing Building at least one (1) day in advance of all such meetings.
- 4. The Selection Committee, as approved by the County Manager, will visit equipment sites and operate the equipment. The Selection Committee will make the determination as to acceptability of the equipment offered and will either accept or reject the equipment based on established criteria during this phase of the process (Evaluation Criteria #1-Functional Fit and #4-Equipment Testing).
- 5. Prior to the first meeting of the selection committee, the Purchasing Agent will post a notice announcing the date, time and place of the first committee meeting. Said notice shall be posted in the lobby of the Purchasing Building not less than three (3) working days prior to the meeting. The Purchasing Agent shall also post prior notice of all subsequent committee meetings and shall endeavor to post such notices at least one (1) day in advance of all subsequent meetings.
- 6. Proposals that are accepted will then be evaluated and scored on Evaluation Criteria #2, 3, 5 and 6. The number of pre-qualified proposals will depend on the number and quality of the proposals. The final recommendation will be decided based on review of scores and consensus of committee.
- 7. Subsequent to award, a contract shall be negotiated with one or more of the topranked firms.

Collier County has developed standard contracts that have been approved by County Attorney and the Board of County Commissioners (BCC) for all projects. All respondents to this RFP will be required, if selected to perform the work, to execute the standard contract within forty-five (45) days of Notice of Selection for Award. **This document is available for inspection at the Purchasing Office and a review is encouraged prior to submitting a proposal.**  8. Upon the successful completion of negotiations, contracts will be presented to the Board of County Commissioners for approval.

Proposals received after the published deadline shall not be accepted and will be returned unopened; however, the Purchasing/Purchasing Director (or their designee) shall reserve the right to accept proposals received after the posted deadline under the following conditions:

- 1. The tardy submission of the proposal appears inadvertent; and
- 2. The acceptance of said proposals does not afford any competing firm an unfair advantage in the selection process.

### INSTRUCTION TO PROPOSERS

**PRINCIPALS/COLLUSION:** By submission of this Proposal, the undersigned, as proposer, does declare that the only person or persons interested in this proposal as principal or principals is/are named therein and that no person other than therein mentioned has any interest in this Proposal or in the contract to be entered into; that this Proposal is made without connection with any person, company or parties making a Proposal, and that it is in all respects fair and in good faith without collusion or fraud.

**PROPOSAL WITHDRAWAL:** No Proposal can be withdrawn after it is filed unless the Proposer makes their request in writing to the County **prior** to the time set for the opening of Proposals, or unless the County fails to accept it within sixty (60) days after the date fixed for opening.

**PROPOSER'S CERTIFICATION:** Submission of a signed Proposal is Proposer's certification that the Proposer will accept any awards made to them as a result of said submission of the terms contained therein.

EXCEPTIONS TO INSTRUCTIONS OR CONDITIONS:

Proposers taking exception to any part or section of these instructions or conditions shall indicate such exceptions on their Proposal. Failure to indicate any exceptions shall be interpreted as the Proposer's intent to fully comply with the specifications as written.

LAWS AND REGULATIONS: It shall be understood and agreed that any and all services, materials and equipment shall comply fully with all Local, State and Federal laws and regulations.

**INSURANCE COSTS:** Since these conditions include Insurance Requirements, there may be additional insurance costs to the Proposer's firm. It is, therefore, imperative that the Proposer discuss these requirements with the Proposer's agent, as noted on the Insurance Check List, so that allowances for any additional costs can be made by the Proposer.

The Consultant's obligation under this provision shall not be limited in any way by the agreed upon contract price, or the Consultant's limit of, or lack of, sufficient insurance protection.

### EXPENSES INCURRED IN PREPARING PROPOSAL:

The County accepts no responsibility for any expenses incurred in the Proposal, preparation, or presentation; such expenses to be born exclusively by the Proposer. **QUALIFICATION OF PROPOSERS**: Before the award of any contract, each Proposer may be required to show (to the complete satisfaction of the county Manager or their designee), that they have the necessary facilities, ability and financial resources to furnish the service as specified herein in a satisfactory manner, and they may also be required to show past history and references which will enable the County Manager, or their designee, to satisfy themselves as to the qualifications. Failure to qualify according to the foregoing requirements will justify the County in rejecting a Proposal.

<u>AWARD CHALLENGE</u>: All costs accruing from a Proposal or an award challenged as to quality, etc. (test, etc.) shall be assumed by the challenger.

LOBBYING: As per County Ordinance #99-22, all firms are hereby placed on NOTICE that the Board of County Commissioners does not wish to be lobbied..either individually or collectively...about a project for which a firm has submitted a proposal. Firms and their agents are not to contact members of the County Commission for such purposes as meeting or introduction, luncheons, dinners, etc. During the publication, evaluation and award phases, no firm or their agent shall contact any other employee of Collier County in reference to this solicitation and their prospective or actual Proposal, with the exception of the Purchasing Department except where otherwise expressly permitted by County ordinance, resolution, or by the RFP document. Failure to abide by this provision may serve as grounds for disqualification for this or a future award to the firm,

**PROPOSAL FORM**: Each Proposer must submit the proposal Form included in this Request for Proposal.

**<u>SINGLE PROPOSAL</u>**: Only one Proposal from a legal entity will be considered. If it is found that a Proposer is interested in more than one Proposal, all Proposals in which such a Proposer is interested will be rejected.

SIGNATURE OF PROPOSER: The Proposer must sign the Proposal in the spaces provided for signatures. If the Proposer is an individual, the words "Sole Owner" shall appear after their signature. If the Proposer is a partnership, the word "Partner" shall appear after the signature of one of the partners. If the Proposer is a corporation, the signature required is the Officer, Officers or Individual duly authorized by its by-laws or the Board of Directors to bind the corporation with official corporate seal affixed thereto. **INTERPRETATION OF PROPOSAL DOCUMENTS AND INVESTIGATION OF PROJECT**: Each Proposer shall thoroughly examine the Proposal Documents, and judge for themselves all matters relating to the location and the character of the services they agree to perform. If the Proposer should be of the opinion that the meaning of any part of the proposal Document is doubtful, obscure or contains errors or omissions, they

should report such opinion or opinions to the Purchasing Director.

Neither the County manager nor their staff shall be responsible for oral interpretation given either by themselves or members of their staff. The issuance of a written addendum shall be the only official method whereby such interpretation will be given.

**REJECTION OR ACCEPTANCE OF PROPOSALS**: The right is reserved by Collier County to waive any irregularities in the Proposal, to reject any or all Proposals, to re-solicit for Proposals, if desired, and upon recommendation and justification by Collier County to accept the Proposal which in the judgment of the County is deemed the most advantageous for the public and the County of Collier.

Any Proposal which is incomplete, conditional, obscure or which contains irregularities of any kind, may be cause for rejection of the Proposal. In the event of default of the successful Proposer, or their refusal to enter into the Collier County contract, the County reserves the right to accept the Proposal of any other Proposer or to readvertise using the same or revised documentation, at its sole discretion.

**<u>PROTECTION RIGHTS OF COUNTY</u>**: The County reserves the right to include in any contract document such terms and conditions as it deems necessary for the proper protection of the rights of Collier County.

**PROTEST PROCEDURES**: Any actual or prospective respondent to an Invitation to Bid or Request for Proposal who is aggrieved with respect to the former, shall file a <u>written</u> protest with the Purchasing Director <u>prior</u> to the opening of the Bid or the due date for acceptance of Proposals. All such protests must be filed with the Purchasing Director no later than 11:00 AM Collier County time on the advertised date for the opening of the Bid or the acceptance date for the Request for Proposals.

Award of contract will be made by the Board of County Commissioners in public session. Award recommendations will be posted outside the offices of the Purchasing Department on Wednesdays and Thursdays. Any actual or prospective respondent who desires to formally protest the recommended contract award must file a notice of intent to protest with the Purchasing Director within two (2) calendar days (excluding weekends and County holidays) of the date that the recommended award is posted. Upon filing of said notice, the protesting party will have five (5) days to file a formal protest and will be given instructions as to the form and content requirements of the formal protest.

A copy of the "Protest Policy" is available at the office of the Purchasing Director.


