## 1. REQUESTED MOTION:

<u>ACTION REQUESTED</u>: Approve a budget amendment resolution for FY04-05 in the General fund to receive \$173,260 in Community Services Block Grant money and \$43,166 in Weatherization money from Department of Community Affairs.

WHY ACTION IS NECESSARY: An agreement between the Board of County Commissioners and the Department of Community Affairs was signed by the BoCC on August 10, 2004 on blue sheet #20040967 for the CSBG grant and August 25, 2004 on blue sheet #20041102 for WAP/LIHEAP. Budget amendment resolutions for FY04-05 were not adopted at these times.

**WHAT THE ACTION ACCOMPLISHES:** These funds provide \$173,260 for case management and supportive services for eligible self-sufficiency clients, and \$43,166 for weatherization for low income homeowners.
