2000 News-Press article put it this way: "Obviously, Kearse hasn't forgotten his hometown and old friends. The money hasn't made him forget. The cover of Sport Illustrated hasn't made him forget. The Pro Bowl selection as a rookie hasn't made him forget. The Super Bowl hasn't made him forget either. Kearse often mentions Southwest Florida in

national interviews;" and

Whereas: Kearse has always epitomized the scholar-athlete and has quietly made a

deep impression on his hometown for his kind heart and willingness to give back to the community. His foundation has raised money for hundreds of

children.
