7. <u>BACKGROUND</u> : At the September 22, 2004 Budget Hearing, a motion was passed to provide The Nations Association, Inc. \$20,000 from general fund reserves to reimburse the agency for unforeseen expenses related to Hurricane Charley. The agency indicated that they had lost \$5,000 worth of perishable food items, distributed \$5,000 of food on their shelves, and spent \$10,000 for hurricane victim needs. Funds were made available from general fund reserves to reimburse the agency for the above mentioned expenses.							
The agency will be asked to provide documentation of all expenses accompanied by a statement from the agency's independent auditor attesting that the expenses are documented, directly related to the hurricane, and will not be reimbursed by other funding sources.							
Funds were transferred from General fund reserves as a result of the September 22, 2004 Budget Hearing. Contract will be forwarded to Chairman for signature once prepared.							
8. <u>MANAGEMENT RECOMMENDATIONS</u> :							
Uphold the recommendations of the Partnering for Results Proposal Review Panel not to fund The Nations Association, Inc. Do not fund any not-for-profit agency for hurricane reimbursement. Date: November 5, 2004

Lee County received allegations that the Nations Association ("Nations") Summary: discriminated against African-American citizens because of race and Hispanic citizens because of national origin regarding the provision of food assistance. The investigation found that the evidence is not sufficient to prove the allegations of discrimination.

Allegations: Three different persons contacted Lee County employees complaining about Nations and its Director Rev. Israel Suarez. The allegations made by each person are as follows:

#### Mrs. Murphy

- 1. "[H]e only gives food to peoples from his Church that tithe or people that do him favors."
- 2. "[B]lack people are turned away and sent to the Open Door Food Bank ("Open Door")."
- 3. "'Mr. St. Cerny [should] not be fooled by what he says about feeding 30,000 people.' She says, 'It's an outright lie"

#### Dr. Wiley

The specific nature of his complaints is unknown. However, he spoke with Ann Arnall on this subject on October 19, 2004, noting that he was founder of Wake Up America, a food program. (10/19/04 e-mail from Ann Arnall (Exhibit 3))

#### Luther Jones

- 1. Nations "is discriminating against black people in the neighborhood."
- 2. "[W]hen he worked for the School Board...he personally took ...13 boxes of food over to Nations. There were a couple of black families in there at the time and Mr. Suarez didn't want to give them any of the food...
- 3. "...and he [Suarez] would not sign a receipt for the donated food either." (10/20/04 e-mail from Joyce Belcher (Exhibit 4))

Report of allegations regarding Nations Association

Findings: We were unable to reach Mrs. Murphy. Ms. Belcher noted that she "asked Mrs. Murphy to leave her number several times but [Mrs. Murphy] said she was calling for all the people...thankful that the Commissioners called for an audit of [Nations]." We contacted Nan Summerall, Commissioner Janes' Executive Assistant, who had also spoken to Mrs. Murphy. She did not have a number for her. Ms. Summerall checked the caller ID when Mrs. Murphy called and found no number. (10/20/04 e-mail regarding conversation with Ms. Summerall (Exhibit 5))

As Mrs. Murphy specifically mentioned Open Door, we contacted that organization and spoke with its Director, Rev. Glenda Jeeters. Rev. Jeeters told us that she did not know a Mrs. Murphy. This name did not "ring a bell" with her either as a client or a volunteer. (11/1/04 e-mail regarding interview with Rev. Glenda Jeeters (Exhibit 6))

We contacted Dr. Wiley. We telephoned the number included in Ms. Arnall's e-mail (Exhibit 3). When we asked for Dr. Wiley, the man answering identified himself as "Mr. Wiley". We attempted to raise the matters mentioned in Ms. Arnall's e-mail. Mr. Wiley said that he did not use e-mail. We told Mr. Wiley that we had an e-mail about his conversation with Ms. Arnall. We then read to Mr. Wiley the following, "The person I spoke to is Dr. Wiley. He was the founder of Wake Up America which is also a food program. His number is 561-5672." Mr. Wiley said "she gave you the wrong number, I'm not a doctor." He then terminated the conversation by hanging up. (11/1/04 e-mail regarding telephone contact with Mr. Wiley (Exhibit 7))

We were unable to reach Luther Jones. We contacted him on two occasions – October 28, 2004 and November 3, 2004. On each occasion, we reached an answering system and left a message. These calls were not returned. (10/28/04 and 11/3/04 e-mails regarding contacts with Luther Jones (Exhibits 8, 9)

Rev. Jeeters reported that she had heard reports that Nations would help only people who go "his church". She had also heard complaints that, if you did not tithe to Rev. Suarez's church, he would not "go out of his way" to help. She said that she heard these complaints from African-American and Hispanic people who came to the Open Door for assistance. She also heard this from her former Outreach Director, who she identified only as David. (Exhibit 6, ¶¶ 6, 7)

Rev. Jeeters said that she got a "ball park" of three to five people complaining about being denied assistance by Nations. She said that this was in the more recent years. She specifically remembered receiving "a lot of complaints" during 2002. (Exhibit 6, ¶ 9)

Rev. Jeeters also said that she received complaints about other programs such as the Harry Chapin Food Bank. She said that she also knew that people complained about Open Door. She said that people who come to her are "in emotional distress". For this reason, people have said "vicious things" about others in her presence. (Exhibit 6, ¶15)

Rev. Jeeters specifically mentioned a white couple who had come to see her recently, claming that they had not gotten "enough" food from Nations. The woman "got a lot of

food" from her in 2003. After getting this food, Rev. Jeeters then saw the woman on television receiving food at Nations. This was "the type to go from one place to another" and "go around bad-mouthing you" when she did not get what she wanted. (Exhibit 6, ¶¶ 15-16)

Rev. Jeeters did not know the names of those who complained about Nations. She said that she had served about 70,000 in the seven years she had been operating. She also emphasized that she had no problem with Nations. She also did not want Open Door "to get caught up in this." (Exhibit 6, ¶¶ 10, 4, 8)

<u>Conclusions:</u> We were unable to interview any of the three persons who alleged that Nations denied assistance to African-Americans and Hispanics. The one person we were able to reach, Mr. Wiley, declined to speak to us.

Rev. Jeeters confirmed that she had received complaints from African-Americans and Hispanics that Nations turned them away. She confirmed that she had heard complaints that Nations would refuse service to people who were not members of Rev. Suarez's church.

However, Rev. Jeeters has no problem with Nations. She knows that complaints about Nations and similar food programs, including Open Door, are not uncommon. Some of these complaints are the result of emotional distress that people are experiencing when they seek such services. Others are a result of the tendency of some to "bad-mouth" organizations who do not give them what they want.

While the above allegations are cause for concern, we were unable to make contact with persons who made these allegations. We sought to learn whether these persons would be able to put us in contact with persons who were refused assistance by Nations. With this, we would be able to determine whether such refusal was based on race, national origin, or other factors. Without this, we are unable to determine whether Nations refuses assistance to African-Americans or Hispanics.

Black people and Spanish people. The former Outreach Director, David, would say things to her. If you don't go to his church, he wouldn't go out of his way to help you. A lot of black people

I just don't want to get Open Door Food Bank to get caught up in this.

A ball park? I don't know. Maybe thre to five people. Mostly in the latter three or four years. As she began to get stronger and serve more people, they began to open up to her.

One year 02, seemed like she got a lot of complaints. Fewer in '03. She said that she could not give a name because she served about 70,000. The people who complained who had at one time attended his church. If you go to his church, you could get food. If you didn't he didn't go out of his way to help you. The Spanish complained about this.

03 and 04 they got a calls from Nations. She wasn't sure why this was. She always asks "Who sent you?". many Most of these were black, some were Spanish.

Nations used to call before they sent them. They then began just sending them. She said that she called them and asked them to call before them.

She recently got a call from a homeless man saying that "Nations told me to call you."

She said that Mrs. Murphy does not ring a bell. She has had a lot

People have come to her and complained about Harry Chapin. She knows that people have complained about Open Door. Many of the people they deal with are in emotional distress. They have had vicious things about others in her presence. She had a white couple came to her door at 7:45PM. She told them that she could not open her house up. She went to Nations and other places but didn't get enough. They then said they would come back tomorrow.

The woman of the couple got a lot of food from her last year. She saw her ont TV at Nations last year. She said that she saw the woman on TV. She knew that she was the type to go from one place to the other. If she ran into a problem, she would then go around bad-mouthing you.

She said that she is not against Rev. Suarez, Harry Chapin or any of the food banks. She does not want to get drawn up into this.

Barden gave Rev Jeeters his number and asked her to call him if she had any information on Mrs. Murphy. She said that would look at her records to see if she could find this name.
