# RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA

WHEREAS, the City of Bonita Springs (City) has requested the donation of two parcels of County-owned land in Section 26, Township 47 South, Range 25 East, Lee County, Florida, for future road right-of-way use in conjunction with East Terry Street; and

WHEREAS, Lee County (County) declares that the purpose of this Resolution is to convey to the City of Bonita Springs, a municipality of the State of Florida, the remainder of two pieces of County-owned land located at 10651 and 10681 East Terry Street (STRAP #'s: 26-47-25-B3-00006.0070 & .0080, respectively), originally acquired for road right-of-way purposes for the expansion and improvement of East Terry Street prior to the incorporation of the City of Bonita Springs; and

WHEREAS, the property will be utilized for the City's future road right-of-way use, expansion and development of East Terry Street; and

WHEREAS, pursuant to Section 125.38, F.S., the Board of County Commissioners has the authority to convey County-owned property to the City without advertisement, compensation or consideration because the City is a municipality of the State of Florida; and

WHEREAS, the Board of County Commissioners has determined and is satisfied that the property is not needed for County purposes and that by virtue of conveyance to the City, the property will benefit the public or community interest and welfare and will be in public ownership.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, THAT:

The Board of County Commissioners authorizes the conveyance the County's interest in the remainder of two pieces of real property located at 10651 and 10681 East Terry Street (STRAP #'s: 26-47-25-B3-00006.0070 & .0080, respectively) described in attached Exhibit "A" to the City of Bonita Springs, a municipality of the State of Florida, without payment of any consideration therefore.

The Chairman of the Board of County Commissioners is authorized to execute the County Deed for and on behalf of Lee County for the conveyance of the County's interest in the real property described in attached Exhibit "A" and to do those things necessary to complete the conveyance of the real property interest to the City.

### **COUNTY DEED**

(Statutory)

THIS DEED, executed this \_\_\_\_\_ day of \_\_\_\_\_, 2004, by LEE COUNTY, FLORIDA, a political subdivision of the State of Florida, whose address is Post Office Box 398, Fort Myers, Florida 33902-0398 (County), Grantor, to the CITY OF BONITA SPRINGS, a municipality of the State of the State of Florida, whose address is 9220 Bonita Beach Road, Suite 111, Bonita Springs, Florida 34135, as Grantee.

**WITNESSETH:** The County, for and in consideration of the sum of Ten and xx/100 Dollars (\$10.00) to it in hand paid by the Grantee, receipt whereof is hereby acknowledged, has granted, bargained and sold to the Grantee, the following described real property, lying and being in Lee County, Florida:

Any remaining right, title or interest the County may have in the following two properties:

The real property described in the Warranty Deed of Albert F. Hamilton and Jessie Hamilton to Lee County, Florida, dated February 20, 1991 and recorded in the Official Records (O.R.) of the public records of Lee County, Florida, in O.R. Book 2205, Page 2220;

and

The real property described in the Warranty Deed of Franklin G. Fortier and Jean M. Fortier to Lee County, Florida, dated March 19, 1991 and recorded in the Official Records (O.R.) of the public records of Lee County, Florida, in O.R. Book 2210, Page 4449.

Both parcels subject to all easements, rights-of-way and restrictions of record.

In accordance with Florida Statutes s. 270.11, the County hereby reserves an undivided three-fourths interest in, and title in and to an undivided three-fourths interest in, all the phosphate, minerals, and metals that are or may be in, on, or under the subject land and an undivided one-half interest in all the petroleum that is or may be in, on, or under the subject land with the privilege to mine and develop each interest. Provided, however, the right of entry with respect to any interest in phosphate, minerals, metals or petroleum reserved in favor of the County is hereby released if the subject parcel being conveyed is or has always been a contiguous tract of less than 20 acres in the aggregate under the same ownership.

Said property is being conveyed pursuant to Chapter 125.38, Florida Statutes.

This grant conveys only the interest of the County and its Board of County Commissioners in the property herein described, and does not warrant the title or represent any state of facts concerning the title.
