ACTION REQUESTED: Request Board of County Commissioners to adopt a resolution authorizing the borrowing of up to \$45,000,000 from the Tax Exempt Commercial Paper Program for the new Sanibel Causeway Span A and the Toll Plaza, approve budget amendment resolution for implementation upon approval of the commercial paper loan and amend the FY04-05 to FY08-09 CIP accordingly.

WHY ACTION IS NECESSARY: Projects must be included in a resolution prior to funding the improvements with Commercial Paper.

WHAT ACTION ACCOMPLISHES: Approval of the resolution allows for specific draws on the credit line to be made to provide construction funds.

BACKGROUND: On April 27, 2004, the Board of County Commissioners approved the borrowing of up to \$40,000,000 from the Tax Exempt Commercial Paper Program for the acceptance of bids for Spans B & C of the Sanibel Causeway (Blue Sheet #20040509). Of that authorization, \$20 million has been drawn down on June 10, 2004. The City of Sanibel's lawsuit relative to Span A has not been settled to date and has prevented the County from securing permanent bond financing. Therefore, in order to pursue financing for the balance of the project, this agenda item will authorize an additional borrowing of up to \$45,000,000 from the Tax Exempt Commercial Paper Program to provide funding to accept bids for Span A and the Sanibel Toll Plaza. The borrowing would be for the period through 2009.

The Department of Transportation has indicated that it hopes to accept bids for Span A in December, 2004.

8. MANAGEMENT RECOMMENDATIONS: Approve the Commercial Paper resolution.
