BACKGROUND: WCIND is a taxing district that includes Manatee, Sarasota, Charlotte and Lee Counties, Member counties can request grant funding for boating and navigation related projects on an annual basis. Applications and an accompanying Resolution are required submittals as part of the request process. The Resolution contains a prioritized list of project requests. Projects were considered based on Lee County needs, municipal and nonprofit agency requests. A prioritized project list totaling \$1,126,498.55 was voted on and approved by the Waterways Advisory Committee (WAC) on June 9th, 2004. Staff agrees with the WAC list. Recommendations are based on WCIND eligibility criteria, anticipated fund availability, benefits to Lee County, previous funding experience, and input from the Waterways Advisory Committee, Natural Resources Division staff and the WCIND Executive Director. Project summaries and comments are included in the backup materials. No funds are required for this request. A budget amendment resolution will be prepared and submitted for approval when grant funding is awarded. Any successful projects will also be governed by formal agreements between Lee County and WCIND. Sub-grantees (as noted in summaries) will be required to enter into an Agreement with Lee County after contracts are signed with WCIND. It is recommended that projects be deleted or funding reduced in order of the lowest priority if the requested total is not available from WCIND.
