The Department of Transportation submitted a request to Contracts Management to obtain bids for the Countywide Resurface and Rebuild Program (Lehigh Acres, South Fort Myers and North Fort Myers) project. The expected cost of the resurfacing required the use of the formal sealed bid procedure.

On the bidding deadline of October 27, 2004, Contracts received three (3) bids. The bids have been reviewed by the Department of Transportation and it is being recommended that award be made to the lowest responsive/responsible bidder, Ajax Paving Industries, Inc., for a total not-to-exceed contract amount of \$940,326.32, with a final project completion time of 180 calendar days.
