7. BACKGROUND:

After inspection, Lee County crews found cracks in the girders to the structures of the Sanibel Causeway. The Department of Transportation took the necessary steps to have emergency repairs done to the Sanibel Causeway Spans C.

Pursuant to the Lee County Contract Manual, Section 1, 1.6 Emergency Services, the County Manager may authorize emergency services of Board authorization or higher (over \$50,000) and waive any bid requirements and then recommend to the Board of County Commissioners its approval of the project.

Due to the emergency nature the Department of Transportation is requesting an after the fact approval of this emergency to Zep Construction in the amount of \$440,000.00.
